Amendments proposed by Senate Committee on Senate and Governmental Affairs to Reengrossed House Bill No. 947 by Representative Pope

1 AMENDMENT NO. 1

2 On page 1, delete lines 2 through 10, and insert the following:

3 "To amend and reenact R.S. 17:7(22) and to enact R.S. 17:7(33) and R.S. 36:
 4 104(A)(15), 954(A)(9), 204(A)(9), 234(A)(14), 254(A)(15), 304(A)(9), 354(A)(18),
 5 404(A)(10), 454(A)(9), 474(A)(13), 505(A)(10), 605(A)(9), 624(A)(9), 645(A)(9),
 6 682(B)(8), 702(8), 722(8), 742(10), 764(A)(8), and 784(A)(9), relative to reporting of
 7 information to the legislature concerning the administration of state departments; to provide
 8 for duties of the superintendent of education, and the State Board of Elementary and
 9 Secondary Education; to provide for duties of the secretary or the equivalent of the
 10 Department of Economic Development, Department of Elderly Affairs, Department of
 11 Culture, Recreation and Tourism, Department of Environmental Quality, Department of
 12 Health and Hospitals, Louisiana Workforce Commission, Department of Natural Resources,
 13 Department of Public Safety and Corrections, Department of Revenue, Department of
 14 Children and Family Services, Department of Transportation and Development, Department
 15 of Wildlife and Fisheries, Department of Agriculture and Forestry, Department of Insurance,
 16 Department of Justice, Department of Public Service, Department of State, Department of
 17 Treasury, and Department of Veterans Affairs; to require these entities to report to the
 18 legislature certain information concerning organizational matters and staff salaries; to
 19 specify the period for reporting of such information; to provide for technical corrections; and
 20 to provide for related matters."
