| 4 | WHEREAS, the Doctorate of Humane Letters is the highest honor that the university |
| 5 | can bestow upon an individual; and |
| 6 | WHEREAS, the honorary degree was conferred upon Willie Landry Mount at the |
| 7 | one hundred forty-sixth commencement ceremony of McNeese State University on May 14, |
| 8 | 2016; and |
| 9 | WHEREAS, Ms. Mount is a successful business owner, outstanding civic leader, a |
| 10 | distinguished former mayor, former state senator, and an ardent supporter of McNeese State |
| 11 | University; and |
| 12 | WHEREAS, she received her Bachelor of Science in Business Administration from |
| 13 | McNeese State University in 1974, serves on the McNeese Foundation Board of Directors, |
| 14 | is a recipient of the McNeese Distinguished Alumni Award, and has been inducted into the |
| 15 | McNeese College of Business Hall of Fame; and |
| 16 | WHEREAS, Ms. Mount was the first female mayor of the city of Lake Charles and |
| 17 | served in that capacity for six and one-half years before becoming the first female elected |
| 18 | to represent District 27 in the Louisiana Senate; and |

| 1 | WHEREAS, she served three terms in the Senate, from 2000-2012, and in her third |

| 3 | Highways, and Public Works and Judiciary C committees, Legislative Audit Advisory |
| 4 | Council, and served on the Joint Legislative Committee on the Budget, Select Committee |
| 5 | on Women and Children, Select Committee on Coastal Restoration and Flood Control, Child |
| 6 | Poverty Prevention Council, Health Committee of the National Conference of State |
| 7 | Legislatures, Southern Growth Policies Board, and Louisiana Health Works Commission, |
| 8 | and was an interim member of the Senate Committee on Finance; and |
| 9 | WHEREAS, Ms. Mount previously served as the chair of the Revenue and Fiscal |
| 10 | Affairs Committee, as vice-chair of the Education Committee, and was a member of a |
| 11 | number of committees, including Senate Select Committee on Consumer Affairs, Judiciary |
| 12 | B, State Technology Advisory, Millennium Port, Dyslexia Study Committee, Reading |
| 13 | Leadership Team, Joint Legislative Juvenile Justice, School Finance Review, Commission |
| 14 | on French, and the Commission on Best Practices in School Discipline; and |
| 15 | WHEREAS, she has been very active in a variety of civic and community betterment |
| 16 | projects, including past president of the Louisiana Conference of Mayors and as a member |
| 17 | on the executive boards of the Louisiana Municipal Association and the Council for a Better |
| 18 | Louisiana; and |
| 19 | WHEREAS, she also serves on the Christus St. Patrick Board of Councilors, and |
| 20 | previously served on the United Way Community Foundation, Prevent Child Abuse |
| 21 | Louisiana Board, United Methodist Foundation, and Alzheimer's Association State Board; |
| 22 | and |
| 23 | WHEREAS, because of Ms. Mount's leadership, she has been awarded the |
| 24 | Distinguished Citizen of the Year by the Boy Scouts, Public Official of the Year by the |
| 25 | Msgr. Cramers Knights of Columbus, National Association of Social Workers, and |
| 26 | Louisiana Association of Museums, Woman of the Year by the Quota Club, and Citizen of |
| 27 | the Year by the Kiwanis Club of Lake Charles, and U.S. Marine Corps League; and |
| 28 | WHEREAS, she also received the Community Service Award from the North Lake |
| 29 | Charles Kiwanis Club, the Doretha Combre Award from the National Association for the |
| 30 | Advancement of Colored People, and the Patron of Architecture Award from the Louisiana |

1 Architectural Foundation; and

| 2 | WHEREAS, Delta Kappa Gamma Society International honored her with its Golden |

| 5 | WHEREAS, Ms. Mount was named a Special Friend of the Louisiana Municipal |
| 6 | Association in 2002, 2003, and 2004 and was recognized by the New Orleans Regional |
| 7 | Chamber and Metro Vision for her efforts during the 2003 legislative session; and |
| 8 | WHEREAS, she was also named Champion for Children by Prevent Child Abuse |
| 9 | Louisiana, in addition to receiving the Ron Schroeder Award from the MicroEnterprise |
| 10 | Development Alliance of Louisiana and the Wilton J. Bellard Jr. Champion Award from the |
| 11 | Southwest Louisiana Center for Health Services; and |
| 12 | WHEREAS, Ms. Mount has been recognized as Legislator of the Year by the |
| 13 | Louisiana Orthopaedic Association, the Louisiana Association of Principals, the Louisiana |
| 14 | Partnership for Children and Families, and the Childcare Association of Louisiana, and was |
| 15 | selected as a recipient of the Louisiana Endowment for the Humanities Legislative Award |
| 16 | in 2007, the Leadership in the Community Award by Women of Excellence, the Christus |
| 17 | Health Eagle Award in 2008, and the LegisGator Champion Award in 2008 and 2009; and |
| 18 | WHEREAS, she received the Chamber Southwest Louisiana Chairman's Award in |
| 19 | 2009, the Senator Diana Bajoie Award, the LegisGator Business Champion Award in 2010 |
| 20 | and 2011, and was the Nurse Family Partnership Legislative Champion for 2010; and |
| 21 | WHEREAS, Ms. Mount has received the 2010 Louisiana Family Forum Family |
| 22 | Advocate Award and was honored by the U.S. Marine Corps Toys for Tots program; and |
| 23 | WHEREAS, in 2011, she received the LegisGator Legacy of Service Award and the |
| 24 | Public Service Award from the Southwest Louisiana Convention and Visitors Bureau, and |
| 25 | in recent years she was given the Junior League of Lake Charles Della Krause Theilen |
| 26 | Voluntarism Award, named a Pinnacle Light of Hope Honoree, and had her lifelong |
| 27 | commitment to philanthropy honored during National Philanthropy Day; and |
| 28 | WHEREAS, Ms. Mount has served as an outstanding leader in civic and professional |
| 29 | organizations through her service on a multitude of boards and organizations at the local and |
| 30 | state levels, including the Calcasieu Community Clinic, Library Board of Control for the |
