HEALTH SERVICES: Authorizes development of a plan for citywide delivery of health services in New Orleans

A RESOLUTION

2	To authorize and request a comprehensive plan for citywide delivery of health services in
3	New Orleans, and to form a study committee to assist with development of the plan.
4	WHEREAS, the recent ten-year anniversary of the devastation wrought by Hurricane
5	Katrina offered an opportunity to reflect upon the ongoing recovery of the City of New
6	Orleans; and
7	WHEREAS, just as they did before Hurricane Katrina, the healthcare institutions of
8	New Orleans play a vital role in the health and well-being of the city's people, and,
9	collectively, have steadily rebuilt their facilities and services through the post-Katrina years;
10	and
11	WHEREAS, while having easily accessible medical facilities with adequate capacity
12	to care for patients is a priority for any city, an emerging priority for New Orleans is to align
13	its system of health services so that health care remains accessible and is also delivered in
14	the most efficient and effective manner; and
15	WHEREAS, New Orleans has a high concentration of hospitals as well as a high
16	concentration of healthcare professionals, largely due to the presence of its two medical
17	schools and schools of allied health, nursing, and dentistry; and
18	WHEREAS, other U.S. cities have undertaken efforts to develop cohesive plans to
19	align healthcare infrastructure existing within specific geographic areas; and

1	WHEREAS, an example of such an effort in this state can be found in Baton Rouge,
2	where the Baton Rouge Area Foundation commissioned a plan which designated an area of
3	the city with abundant healthcare infrastructure as a "health district"; and
4	WHEREAS, it is appropriate as a matter of public health policy to consider the
5	benefits of a prospective plan for optimizing health services delivery in New Orleans so that
6	the health system of the city can efficiently meet the needs of its population today and into
7	the future.
8	THEREFORE, BE IT RESOLVED that the House of Representatives of the
9	Legislature of Louisiana does hereby authorize and request a comprehensive plan for
10	citywide delivery of health services in New Orleans.
11	BE IT FURTHER RESOLVED that a special study committee is hereby formed for
12	the purpose of assisting with development of the plan.
13	BE IT FURTHER RESOLVED that the study committee shall be composed of the
14	following members:
15	(1) The Health Commissioner of the City of New Orleans or his designee.
16	(2) One healthcare consumer representative appointed by the Health Commissioner
17	of the City of New Orleans.
18	(3) The chancellor of the Louisiana State University Health Sciences Center at New
19	Orleans or his designee.
20	(4) The dean of the School of Allied Health Professions of the Louisiana State
21	University Health Sciences Center at New Orleans or his designee.
22	(5) The dean of the School of Nursing of the Louisiana State University Health
23	Sciences Center at New Orleans or his designee.
24	(6) The dean of the School of Dentistry of the Louisiana State University Health
25	Sciences Center at New Orleans or his designee.
26	(7) The dean of the Tulane University School of Public Health and Tropical
27	Medicine or his designee.
28	(8) The president and chief executive officer of Tulane Health System or his
29	designee.

1	(9) The president and office executive officer of LCMC Health New Officials of his
2	designee.
3	(10) The chief executive officer of Ochsner Health System or his designee.
4	(11) The chief executive officer of New Orleans East Hospital or his designee.
5	(12) The president of HCA MidAmerica Division or his designee.
6	(13) The executive director of the Louisiana Primary Care Association or his
7	designee.
8	(14) The chief executive officer of the St. Thomas Community Health Center or his
9	designee.
0	(15) The president and chief executive officer of Daughters of Charity Services of
1	New Orleans or his designee.
12	(16) The chief executive officer of Baptist Community Health Services, Inc., or his
13	designee.
4	(17) The executive director of the Metropolitan Human Services District or his
15	designee.
16	(18) The chief executive officer of the Louisiana Public Health Institute or his
17	designee.
8	(19) The secretary of the Department of Health and Hospitals or his designee.
19	(20) The president and chief executive officer of Greater New Orleans, Inc., or his
20	designee.

22	Foundation or his designee.
23	(22) The executive director of 504HealthNet, Inc., or his designee.
24	(23) The executive director of the Louisiana Emergency Response Network Board
25	or his designee.
26	(24) A representative of the New Orleans Emergency Medical Technician Services
27	as designated by the Health Commissioner of the city of New Orleans.
28	BE IT FURTHER RESOLVED that the New Orleans Health Department shall have
29	primary responsibility for coordinating the development of the plan, and may convene
30	meetings of the study committee as necessary to carry out this purpose.

1 BE IT FURTHER RESOLVED that no later than thirty days prior to the convening 2 of the 2017 Regular Session of the Legislature, the New Orleans Health Department shall 3 submit a written report addressing the status of the development of the plan to the House of 4 Representatives contingent of the Orleans Delegation of the Legislature. 5 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 6 Health Commissioner of the City of New Orleans; the dean of the School of Allied Health Professions, the dean of the School of Nursing, the dean of the School of Dentistry, and the 7 8 chancellor of the Louisiana State University Health Sciences Center at New Orleans; the 9 dean of the Tulane University School of Public Health and Tropical Medicine; the president 10 and chief executive officer of Tulane Health System; the president and chief executive 11 officer of Children's Hospital New Orleans; the chief executive officer of Ochsner Health 12 System; the chief executive officer of New Orleans East Hospital; the president of HCA 13 MidAmerica Division; the executive director of the Louisiana Primary Care Association; the 14 chief executive officer of the St. Thomas Community Health Center; the president and chief 15 executive officer of Daughters of Charity Services of New Orleans; the chief executive 16 officer of Baptist Community Health Services, Inc.; the executive director of the 17 Metropolitan Human Services District; the chief executive officer of the Louisiana Public 18 Health Institute; the secretary of the Department of Health and Hospitals; the president and 19 chief executive officer of Greater New Orleans, Inc.; and the president and chief executive
