LEVEES: Urges and requests the Louisiana State Law Institute to study the issue of preferences for Louisiana contractors for public works contracts

1	A CONCURRENT RESOLUTION
2	To urge and request the Louisiana State Law Institute to study the issue of preferences in
3	favor of Louisiana contractors for contracts related to integrated coastal protection
4	projects and to report the findings, in writing, to the Senate and House committees
5	on transportation, highways and public works and the member of the House of
6	Representatives representing House District Number 52.
7	WHEREAS, the Louisiana State Law Institute is partially purposed to conduct
8	special research for the Legislature and its individual members, at their request, on matters
9	of legislative interest; and
10	WHEREAS, generally, Louisiana's resident preference statutes, R.S. 39:1604.2, and
11	R.S. 38:2225, require preference be given to a contractor domiciled in the state of Louisiana
12	over a contractor domiciled in a state that provides for a preference, percentage or otherwise,
13	in favor of its state's contractors over Louisiana contractors for the same type of work; and
14	WHEREAS, R.S. 49:214.2 defines integrated coastal protection as plans, projects,
15	policies, and programs intended to provide hurricane protection or coastal conservation or
16	restoration, and shall include but not be limited to coastal restoration; coastal protection;
17	infrastructure; storm damage reduction; flood control; water resources development; erosion
18	control measures; marsh management; diversions; saltwater intrusion prevention; wetlands
19	and central wetlands conservation, enhancement, and restoration; barrier island and shoreline
20	stabilization and preservation; coastal passes stabilization and restoration; mitigation; storm
21	surge reduction; or beneficial use projects; and

1 WHEREAS, Louisiana is leading the country for efforts in coastal restoration and 2 technology and advancement and also in terms of the economy and ability to create jobs and 3 salaries; and 4 WHEREAS, nonresident contractors have completed work in the state of Louisiana 5 which resulted in expenditures, cost overruns, and change orders due to a lack of familiarity 6 with Louisiana's habitat and environment; and 7 WHEREAS, the state of Louisiana invests over five hundred million dollars per year 8 in coastal restoration and protection of the Louisiana coast and as such, the state should be 9 receiving the maximum benefit for its investment; and 10 WHEREAS, resident contractors who possess indigenous environmental knowledge 11 which could yield cost savings to the state should be afforded an increased opportunity to 12 have a share in the investment and take advantage of the opportunity presented to the state. 13 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 14 urge and request the Louisiana State Law Institute to study the issue of preference given to 15 Louisiana contractors on contracts for integrated coastal protection projects. 16 BE IT FURTHER RESOLVED, in studying the issue of preference in certain 17 integrated coastal protection projects, the Louisiana State Law Institute shall consider and 18 determine the following: 19 (1) Whether, in letting contracts for public work for integrated coastal protection 20 projects by any public entity, except contracts financed in whole or in part by contributions 21 or loans from any agency of the United States government, preference shall be given to 22 Louisiana resident contractors over nonresident contractors? 23 (2) Whether, when competitive bidding is not required, a contract for integrated 24 coastal protection projects shall be awarded to a Louisiana resident contractor, if there is one 25 available with the expertise required for the specific job? 26 (3) Whether, when competitive bidding is required by law, a contract for integrated

20 (3) whence, when competitive ordening is required by law, a contract for integrated 27 coastal protection projects shall be awarded to the Louisiana resident contractor making the 28 lowest responsible bid, if the bid is not more than ten percent higher than the lowest 29 responsible nonresident bid and the resident contractor agrees to revise his bid to be no more 30 than the lowest responsible nonresident bid?

1	(4) What effect a strict preference law will have on resident contractors working
2	outside of the state of Louisiana?
3	BE IT FURTHER RESOLVED that the Louisiana State Law Institute shall complete
4	a study, which shall also consider any advantages or disadvantages of granting a preference
5	to Louisiana resident contractors on contracts for integrated coastal protection projects, and
6	address the competitive bidding process on contracts for integrated coastal protection
7	projects.
8	BE IT FURTHER RESOLVED that the Louisiana State Law Institute shall complete
9	a written report addressing the issues with granting a preference to Louisiana contractors on
10	contracts for integrated coastal protection projects considering competitive bidding.
11	BE IT FURTHER RESOLVED that the Louisiana State Law Institute shall submit
12	the report to the Senate and House committees on transportation, highways and public works
13	and to the member of the House of Representatives representing House District Number 52
14	on or before February 1, 2017.
15	BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to the
16	president of the Louisiana State Law Institute.
