- "(a) Two members One member shall be appointed by the state representative for House District No. 29, one of whom who shall be a representative of the business community.
  - (b) Two members shall be appointed by the state senator for Senate District No. 15.
  - (c) One member shall be appointed by the mayor-president of the parish of East Baton Rouge.
  - (d) One member shall be appointed by the member or members of the governing authority of the parish of East Baton Rouge who represent the district.
  - (e) One member shall be appointed by the owner of the largest parcel of land located within the district.
  - (f) One member shall be appointed by the state representative for House District No. 61.
  - (g) One member shall be appointed by the state representative for House <u>District No. 63.</u>
  - (g)(h) One member shall be appointed by the state representative for House District No. 67.
  - (h)(i) One member shall be appointed by the state representative for House District No. 101.

  - (2)(a)(i) Members serving pursuant to Subparagraphs (1)(a) through (i)(j) of this Subsection shall serve four-year terms after initial terms as provided by Item (ii) of this Subparagraph.
  - (b) Members serving pursuant to Subparagraphs  $\frac{(1)(j)}{(1)}$  and  $\frac{(l)}{(1)}$  of this Subsection shall serve at the pleasure of the subcommittee formed by the board."
