Provides relative to the per diem paid to members of the board of commissioners of waterworks districts located in certain

parishes

PURPOSE OF THE BILL: Provides for an increase in the amount of per diem from \$60 to \$120 per meeting, per member for members of the board of supervisors for Waterworks Districts in parishes with a population of not less than twenty thousand persons and not more than twenty thousand five hundred persons.

Based upon the last federal census, only one parish (East Feliciana) has a waterworks district that would be impacted by the legislation.

EXPENDITURE EXPLANATION

This bill could increase local fund expenditures for the East Feliciana Waterworks District No. 7 by a maximum of \$10,800 per year.

The proposed bill provides that the governing authority may fix per diem at \$120 per meeting for a maximum number of 36 meetings per year.

Currently, there are 5 members of the East Feliciana Waterworks District No. 7 who receive a per diem of \$60 per meeting for approximately 12 meetings per year at a cost of \$3,600 annually. According to a representative of the East Feliciana Waterworks District No. 7, this bill will only result in an additional cost of \$3,600 annually, as they plan to have only 12 meetings (\$60 per meeting increase * 12 meetings * 5 members).

However, if the board members were to receive what is provided for in this bill, the **maximum potential impact** could be \$10,800 annually (\$60 per meeting increase * 36 meeting maximum * 5 members).

REVENUE EXPLANATION

There is no anticipated direct material effect on local governmental revenues as a result of this measure.
