1	AN ACT
2	To amend and reenact R.S. 17:7(22) and to enact R.S. 17:7(33) and R.S. 36:104(A)(15),
3	154(A)(9), 204(A)(9), 234(A)(14), 254(A)(15), 304(A)(9), 354(A)(18), 404(A)(10),
4	454(A)(9), 474(A)(13), 504(A)(10), 605(A)(9), 624(A)(9), 645(A)(9), 682(B)(8),
5	702(8), 722(8), 742(10), 764(A)(8), and 784(A)(9), relative to reporting of
6	information to the legislature concerning the administration of state departments; to
7	provide for duties of the superintendent of education, and the State Board of
8	Elementary and Secondary Education; to provide for duties of the secretary or the
9	equivalent of the Department of Economic Development, Department of Elderly
10	Affairs, Department of Culture, Recreation and Tourism, Department of
11	Environmental Quality, Department of Health and Hospitals, Louisiana Workforce
12	Commission, Department of Natural Resources, Department of Public Safety and
13	Corrections, Department of Revenue, Department of Children and Family Services,
14	Department of Transportation and Development, Department of Wildlife and
15	Fisheries, Department of Agriculture and Forestry, Department of Insurance,
16	Department of Justice, Department of Public Service, Department of State,
17	Department of Treasury, and Department of Veterans Affairs; to require these
18	entities to report to the legislature certain information concerning organizational
19	matters and staff salaries; to specify the period for reporting of such information; to
20	provide for technical corrections; and to provide for related matters.
