<u>Current law</u> mandates the Sales Tax Streamlining and Modernization Commission to provide an interim report by January, 2016. Local sales tax recommendations required the approval of 3/4 of the Commission. The Commission will terminate on June 30, 2017.

<u>Proposed law</u> retains current law and extends the Commission to June 30, 2018 with a 2/3 vote of the commission membership prior to June 30, 2017. The bill also establishes a subcommittee to develop recommendations of potential policy changes regarding coordinated multi-parish sales and use tax audits due by January 15, 2017. Membership includes commission members representing the Police Jury Association of LA, the LA Municipal Association, LA School Board Association, LA Association of Tax Administrators, LA Sheriffs Association, LA Multi-parish Tax Commission, Department of Revenue, and the LA Legislative Auditor.
