**EXPENDITURE EXPLANATION**

This measure is anticipated to have a nominal impact on expenditures of DHH. The bill provides for the renaming of the Department of Health and Hospitals to the Louisiana Department of Health. To the extent DHH makes these changes over the normal course of business and not all in FY 17, name changes associated with car decals, stationary, business cards, employee I.D. badges, web pages, and any other incidental materials is not anticipated to result in new costs. However, removing and replacing permanent building signage on any DHH building is anticipated to result in a nominal expense.
