HOUSE RESOLUTION NO. 8

ELECTIONS/ABSENTEE VOTE: Requests the secretary of state to study same-day voter registration for in-person early voting

A RESOLUTION

2	To urge and request the secretary of state to examine the feasibility and advisability of
3	allowing a person who appears in person at the office of the registrar of voters during
4	the early voting period to register to vote and to vote on the same day and to include
5	his findings and recommendations in the report required to be filed prior to January
6	1, 2017, pursuant to R.S. 18:135.1.
7	WHEREAS, elections are a fundamental part of federal, state, and local government;
8	they allow citizens to exercise their right to vote and thereby to participate in the government
9	of their country, state, and community; and
10	WHEREAS, voting is therefore a civic duty of paramount importance; and
11	WHEREAS, the Constitution of Louisiana and the Louisiana Election Code require
12	a person to be registered to vote in order to participate in an election; and
13	WHEREAS, the Louisiana Election Code currently provides that voter registration
14	records close thirty days prior to an election; and
15	WHEREAS, this has been the case for the majority of the time that Louisiana has
16	provided for voter registration; and
17	WHEREAS, the legislature changed the timing of the close of voter registration
18	records in the 2016 Regular Session; and
19	WHEREAS, beginning February 1, 2017, voter registration records will close twenty
20	days prior to an election for those who register to vote online; and

1	WHEREAS, the Louisiana Election Code provides that any qualified voter may vote
2	in person during the early voting period; and
3	WHEREAS, early voting is conducted at the main offices of registrars of voters, at
4	branch offices of registrars, and at certain additional locations designated by the secretary
5	of state; and
6	WHEREAS, the early voting period is fourteen to seven days prior to the election;
7	and
8	WHEREAS, the voter registration records, therefore, are closed prior to early voting;
9	and
10	WHEREAS, R.S. 18:135.1 requires the secretary of state to examine all of the issues
11	regarding shortening the time period between the close of voter registration and the election,
12	including the availability and use of new voting technology and equipment, any necessary
13	procedural changes relative to voter registration, the conduct of the election, and whether or
14	not it is feasible to shorten the period of time between the close of voter registration and the
15	election; and
16	WHEREAS, this provision of law also requires the secretary of state to submit a
17	report to the governmental affairs committees of the legislature at least every other year; the
18	initial report was due January 1, 2007; and
19	WHEREAS, allowing a person who appears at the office of the registrar of voters
20	during the early voting period to register to vote and to vote on the same day could increase
21	citizen participation in the electoral process and at the same time protect the integrity of the
22	electoral process.
23	THEREFORE, BE IT RESOLVED that the House of Representatives of the
24	Legislature of Louisiana does hereby urge and request the secretary of state to examine the
25	feasibility and advisability of allowing a person who appears in person at the office of the
26	registrar of voters during the early voting period to register to vote and to vote on the same
27	day and to include his findings and recommendations in the report required to be filed prior
28	to January 1, 2017, pursuant to R.S. 18:135.1.
29	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
30	to the secretary of state.
