1 AN ACT 2 To amend and reenact R.S. 26:75(C)(1), 275(B)(1), and 359(B)(1)(h) and (i), (2) and (3), 3 (C), (D), (E), and (F) and to enact R.S. 26:359(B)(4), relative to wine shipped 4 directly to consumers; to provide for sampling of beverages of low alcoholic content; 5 to provide for sampling of beverages of high alcoholic content; to provide with 6 respect to certain requirements for direct shipment sales; to provide for exceptions; 7 to authorize the commissioner to promulgate rules; to provide for permit applications 8 of certain wine producers, manufacturers, and retailers; to provide permit fees; to 9 specify the due date of a monthly statement; to provide for additional penalties for 10 violations; to provide for an effective date; and to provide for related matters. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. R.S. 26:75(C)(1), 275(B)(1), and 359(B)(1)(h) and (i), (2) and (3), (C), 13 (D), (E), and (F) are hereby amended and reenacted and R.S. 26:359(B)(4) is hereby enacted 14 to read as follows: 15 §75. 1 (2) For all purposes under this Title, the point of sale for transactions made 2 pursuant to this Subsection shall be the place of domicile of the wine producer, 3 manufacturer, or retailer. Delivery to the consumer in Louisiana shall be deemed to 4 have occurred upon the placing of such beverages into the possession of a common 5 carrier for transport into the state of Louisiana. In addition to the provisions in 6 Paragraph (1) of this Subsection, the commissioner may promulgate rules in 7 accordance with the Administrative Procedure Act governing the sale and shipment 8 of sparkling wine or still wine directly to a Louisiana consumer.

9 (3) In addition to the provisions of Paragraph (1) of this Subsection, prior to 10 selling or shipping any sparkling wine or still wine directly to any consumer in 11 Louisiana, a wine producer or manufacturer or retailer domiciled outside of 12 Louisiana shall register apply with to the state office of alcohol and tobacco control 13 for a permit to engage in direct shipment of sparkling wine and still wine on a 14 registration an application form promulgated by the commissioner. The registration 15 permit shall be renewed on an annual basis and updated within thirty days of any 16 change of any information contained on the registration application form. The 17 annual fee for such permit shall be one thousand dollars.

18 (4) In addition to the provisions of Paragraph (1) of this Subsection, prior to 19 selling or shipping any sparkling wine or still wine directly to any consumer in 20 Louisiana, a wine producer or manufacturer domiciled outside of Louisiana shall 21 apply to the state office of alcohol and tobacco control for a permit to engage in 22 direct shipment of sparkling wine and still wine on an application form promulgated 23 by the commissioner. The permit shall be renewed on an annual basis and updated 24 within thirty days of any change of any information contained on the application 25 form. The annual fee for such permit shall be two hundred fifty dollars.

C.(1) Any wine producer or manufacturer, domiciled outside of Louisiana,
of sparkling wine or still wine engaging in the direct sale and shipment of such
beverages under the provisions of Subsection B of this Section shall make an annual
application to the secretary of the Department of Revenue for authority to make such
shipments and shall pay an annual fee of one hundred fifty dollars to the Department

of Revenue prior to selling or shipping any sparkling wine or still wine to a consumer in the state of Louisiana.

(2) Any retailer, domiciled outside of Louisiana, of sparkling wine or still wine engaging in the direct shipment of such beverages under the provisions of Subsection B of this Section shall make an annual application to the secretary of the Department of Revenue for the authority to make such shipments and shall pay an annual fee of one thousand dollars to the Department of Revenue prior to selling or shipping any sparkling wine or still wine into the state of Louisiana.

9 (3) The annual application for authority to make such shipments shall be in 10 a written form specified by the secretary of the Department of Revenue, and shall 11 include the express agreement of the out-of-state wine producer, manufacturer, or out 12 of state retailer to pay all excise and sales and use taxes assessed by the state of 13 Louisiana on the sparkling wine or still wine sold and shipped pursuant to Subsection 14 B of this Section. A copy of the current out-of-state wine producer's, manufacturer's, 15 or out of state retailer's license issued to such out-of-state wine producer, 16 manufacturer, or out of state retailer by the state in which the wine producer, 17 manufacturer, or out of state retailer is domiciled shall be submitted to the secretary 18 of the Department of Revenue with the application. No other permit or license shall 19 be required of any such wine producer, manufacturer, or out of state retailer in 20 connection with the direct shipment of sparkling wine or still wine pursuant to 21 Subsection B of this Section.

22 D.(1) Any out-of-state wine producer, manufacturer, or out-of-state retailer 23 who sells and ships directly to a consumer in Louisiana pursuant to Subsection B of 24 this Section shall file a statement quarterly monthly indicating the amount of 25 sparkling wine or still wine shipped to the state of Louisiana with the secretary of the 26 Department of Revenue. The statement shall be filed by January twentieth, April 27 twentieth, July twentieth, and October the twentieth of each calendar year month and 28 shall indicate the total number of bottles sold and shipped during the preceding 29 month three-month period, the sizes of those bottles, the name brand of each 30 sparkling wine or still wine included in such shipments, the quantities of each

1	sparkling wine or still wine included in such shipments, and the price of each item
2	included in such shipments. All excise and sales and use taxes due to the state of
3	Louisiana on the sparkling wine or still wine sold and shipped pursuant to Subsection
4	B of this Section shall be remitted by company check drawn on an account in the
5	name of the permit holder or by electronic funds transfer at the time of the filing of
6	the required statement, and copies of all invoices transmitted with each shipment
7	shall be attached to the statement. This statement shall be made on forms prescribed
8	and furnished by the secretary of the Department of Revenue and shall include such
9	other information as the secretary of the Department of Revenue may require.

10 (2) Upon the request of the commissioner, the secretary of the Department
 11 of Revenue may provide copies of the annual application or quarterly monthly
 12 statements filed by any <u>out-of-state</u> wine producer or manufacturer or any out-of-
 13 state retailer selling or shipping wine directly to a Louisiana consumer.

(3)(a) Any person who transports sparkling wine or still wine for direct
shipment into or out of the state in accordance with this Section shall register with
the commissioner of the state office of alcohol and tobacco control.

(b) The commissioner shall promulgate rules in accordance with the
Administrative Procedure Act for transport registrants that shall include regular
reporting requirements related to size of containers and quantities of sparkling wine
and still wine contained in each shipment <u>and any other reporting requirements</u>
<u>deemed necessary by the commissioner</u>. The rules shall include requirements that
prevent sales and deliveries to underage persons.

(c) Any person who transports sparkling wine or still wine for direct
shipment into or out of the state in violation of this Section or the administrative
rules shall be subject to a civil penalty of up to twenty-five thousand dollars or the
seizure of any sparkling wine or still wine, or both.

E. The provisions of R.S. 26:85, 142, 143, 348 through 350, 360, 364, and 365 shall not apply to wine producers, manufacturers, and retailers only in connection with direct sales and shipments when authorized to engage in the direct

sale and shipment of sparkling wine or still wine under the provisions of Subsection B of this Section.

3 F. Any out-of-state retailer domiciled outside of Louisiana or any wine 4 producer or manufacturer who violates any provision of this Section shall be subject 5 to a civil penalty in the amount of twenty-five thousand dollars. Any out-of-state 6 retailer domiciled outside of Louisiana or any wine producer or manufacturer that 7 sells and ships directly to consumers in Louisiana pursuant to Subsection B of this 8 Section shall, on the application for authority to make such shipments filed with the 9 secretary of the Department of Revenue and on the application for a permit filed with 10 the state office of alcohol and tobacco control in accordance with Subsection C of 11 this Section, acknowledge in writing the civil penalty established in this Subsection 12 and shall consent to the imposition thereof upon violation of this Section. The 13 secretary or the commissioner may initiate and maintain a civil action in a court of 14 competent jurisdiction to enjoin any violation of this Section and to recover the civil 15 penalty established in this Subsection, together with all costs and attorney fees 16 incurred by the secretary or the commissioner incidental to any such action. 17

18 Section 2. This Act shall become effective on July 1, 2016; if vetoed by the governor
19 and subsequently approved by the legislature, this Act shall become effective on July 1,
20 2016, or on the day following such approval by the legislature, whichever is later.
