EMPLOYMENT EN NO IMPACT See Note Authorizes private employers to provide employment preferences for veterans. (8/1/16)

<u>Proposed law</u> provides that private employers may adopt an employment policy that gives preference in hiring to all of the following: (1) honorably discharged veteran; (2) spouse of a veteran with a service connected disability; (3) unremarried widow or widower of a veteran who died of a service connected disability; (4) unremarried widow or widower of a member of the US Armed Forces who died in the line of duty under combat-related conditions. <u>Proposed law</u> provides the veteran preference system established by private employers shall be similar to the state and city government systems and not considered a violation of any state or local equal employment laws. <u>Proposed law</u> is permissive and not mandatory to private employers. In addition, <u>proposed law</u> provides an employer may voluntarily establish a policy which grants preference in hiring veterans or certain family members of veterans.
