## ACT 6 (HB 20) 2016 First Extraordinary Session Broadwater

Existing law provides for a deduction from corporate income tax for 72% of the amount of net operating loss incurred in La.

<u>Prior law</u> sunset the reduction in the amount of the net operating loss deduction on June 30, 2018, thereby reinstating the amount of the net operating loss deduction to 100% of the amount.

<u>New law</u> prohibits the amount of the deduction from exceeding 72% of the value of La. net income. Further repeals the three-year sunset of the reduction in <u>prior law</u> making the 28% reduction permanent.

Effective Jan. 1, 2016.
