2	To amend and reenact R.S. 15:711(B), relative to work release programs administered by		
3	sheriffs; to require the use of electronic monitoring for supervising inmates		
4	participating in a work release program; and to provide for related matters.		
5	Be it enacted by the Legislature of Louisiana:		
6	Section 1. R.S. 15:711(B) is hereby amended and reenacted to read as follows:		
7	§711. Work release program		
8	* * *		
9	B. Each sheriff shall establish written rules for the administration of the work		
10	release program and shall determine those inmates who may participate in the release		
11	program, except that no inmate may participate in the program if his sentence so		
12	stipulates. Inmates sentenced to the Department of Public Safety and Corrections		
13	who are in the custody of the sheriff shall not be eligible for work release unless such		
14	inmates are in compliance with standards for work release within the department and		
15	written approval of the secretary of the department is obtained. If any inmate		
16	violates the conditions prescribed by the sheriff, his work release privileges may be		
17	withdrawn. Failure to report to or return from the planned employment shall be		
18	considered an escape under the provisions of R.S. 14:110. The sheriff may approve		
19	as work release privileges, placement in universities, colleges, technical, vocational		
20	or trade schools or in sheltered workshops or in training programs designed to

Abstract: Requires the sheriff to use electronic monitoring to supervise inmates participating in a work release program.

<u>Present law</u> provides for the establishment of work release programs administered by the sheriff.

<u>Proposed law</u> retains <u>present law</u> and requires the sheriff of each parish to require an inmate participating in the work release program to wear an electronic monitoring device during the hours of his employment.
