HIGHER EDUCATION: Requires each public postsecondary education management board to develop a centralization plan and a cooperative unification plan and submit them to the legislature

AN ACT

2 To enact R.S. 17:3357, relative to the public postsecondary education management boards; 3 to require the Board of Supervisors of Louisiana State University and Agricultural 4 and Mechanical College, the Board of Supervisors of Southern University and 5 Agricultural and Mechanical College, the Board of Supervisors for the University of 6 Louisiana System, and the Board of Supervisors of Community and Technical 7 Colleges to develop plans and submit them to the legislature; to provide for the 8 content of such plans; to provide for an initial submission deadline and subsequent 9 submission frequency; and to provide for related matters. 10 Be it enacted by the Legislature of Louisiana: 11 Section 1. R.S. 17:3357 is hereby enacted to read as follows: 12 §3357. Plans; centralization and cooperative unification 13 A. The Board of Supervisors of Louisiana State University and Agricultural 14 and Mechanical College, the Board of Supervisors of Southern University and 15 Agricultural and Mechanical College, the Board of Supervisors for the University of 16 Louisiana System, and the Board of Supervisors of Community and Technical 17 Colleges each shall develop the following plans: 18 (1) A plan relative to centralization, which, at a minimum, shall:

17	B. Each board shall submit its initial plans relative to centralization and

20	plans to the committees by January first every four years thereafter.

Abstract: Requires the public postsecondary management boards to develop and submit to the legislature plans relative to centralization and cooperative unification.

Proposed law requires the Board of Supervisors of La. State University and Agricultural and Mechanical College, the Board of Supervisors of Southern University and Agricultural and Mechanical College, the Board of Supervisors for the University of La. System, and the Board of Supervisors of Community and Technical Colleges each to develop the following plans:

- (1) A plan relative to centralization, which, at a minimum, shall:
 - (a) Review centralization efforts and examine potential efficiencies resulting from further centralization of administrative functions, including but not limited to purchasing, payroll, financial aid, maintenance and operations, human resources, and other administrative functions performed on individual campuses.
 - (b) Examine the potential short-term and long-term costs and savings associated with centralization measures.
- (2) A plan relative to cooperative unification, which, at a minimum, shall:
 - (a) Be developed in collaboration with regional stakeholders for institutions within each of the regional labor market areas and for institutions in contiguous regions.
 - (b) Identify potential efficiencies resulting from the unification of functions and processes, including but not limited to academic and technical offerings suited for regional workforce and economic needs, student services, research, purchasing, food services, and security.
 - (c) Examine the potential short-term and long-term costs and savings associated with unification measures.

<u>Proposed law</u> requires each board to submit its initial plans to the House and Senate education committees not later than Jan. 1, 2018, and by Jan. first every four years thereafter.
