Abstract: Shortens the time period within which to give written notice to a producer.

<u>Present law</u> requires that a producer of record be given 15 days written notice by an insurer of the producer's removal as producer of record by the insured during the application period or policy period.

<u>Proposed law</u> changes <u>present law</u> by shortening the time period <u>from</u> 15 days to 10 calendar days.
