FUNDS/FUNDING: Repeals the dedications of state sales and use taxes on hotel rooms into special treasury funds

AN ACT

2 To repeal R.S. 33:4574.7(K) through (M) and R.S. 47:302.2 through 302.55, 322.1 through 3 322.48, and 332.1 through 332.54, relative to the disposition of certain sales tax 4 collections; to repeal special treasury funds that receive a portion of the state sales 5 and use tax from the sales of services for the furnishing of sleeping rooms, cottages, 6 or cabins by hotels; to provide for the transfer of fund balances; to provide for 7 effectiveness; and to provide for related matters. 8 Be it enacted by the Legislature of Louisiana: Section 1. R.S. 33:4574.7(K) through (M) and R.S. 47:302.2 through 302.55, 322.1 9 10 through 322.48, and 332.1 through 332.54 are hereby repealed in their entirety. 11 Section 2. The state treasurer is authorized and directed to transfer any unexpended 12 and unencumbered funds remaining in the funds repealed by Section 1 of this Act to the state 13 general fund after satisfying the appropriations for Fiscal Year 2016-2017 and the 14 appropriations for Fiscal Year 2017-2018 contained in the Act which originated as House 15 Bill No. 1 of the 2017 Regular Session of the Legislature. 16 Section 3. This Act shall take effect and become operative if and when the proposed 17 amendment of Article VII, Sections 18(B), 20(A), and 21(F) of the Constitution of Louisiana

**Abstract:** Repeals all special treasury funds that receive a portion of the state sales and use tax on the furnishing of hotel rooms.

<u>Present law</u> creates special treasury funds that dedicate a portion of the state sales tax on the furnishing of sleeping rooms, cottages, or cabins by hotels collected in each parish and provide for the use of the dedicated funds.

<u>Proposed law</u> repeals the funds created in <u>present law</u>. The funds and the cites are as follows:
