PUBLIC HEALTH. Creates the Louisiana Human Trafficking Prevention Commission and Advisory Board. (8/1/17)

AN ACT

2	To enact Part II of Chapter 28-B of Title 46 of the Louisiana Revised Statutes of 1950, to
3	be comprised of R.S. 46:2165 through 2168, relative to human trafficking; to provide
4	for the Louisiana Human Trafficking Prevention Commission; to provide for the
5	Louisiana Human Trafficking Prevention Commission Advisory Board; to provide
6	for duties; to provide for reporting; to provide for the composition of the commission
7	and board; to provide for meetings; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Part II of Chapter 28-B of Title 46 of the Louisiana Revised Statutes of
10	1950, comprised of R.S. 46:2165 through 2168, is hereby enacted to read as follows:
11	§2165. Louisiana Human Trafficking Prevention Commission
12	A. The Louisiana Human Trafficking Prevention Commission is hereby
13	created within the office of the governor.
14	B. The commission shall do the following:
15	(1) Assist state and local leaders in developing and coordinating human
16	trafficking prevention programs.
17	(2) Conduct a continuing comprehensive review of all existing public and

1	private human trafficking programs to identify gaps in prevention and
2	intervention services.
3	(3) Increase coordination among public and private programs to
4	strengthen prevention and intervention services.
5	(4) Make recommendations with respect to human trafficking prevention
6	and intervention.
7	(5) Develop a state needs assessment and a comprehensive and integrated
8	service delivery approach that meets the needs of all human trafficking victims.
9	(6) Establish a method to transition human trafficking service providers
10	toward evidence-based national best practices focusing on outreach and
11	prevention.
12	(7) Develop a plan that ensures that Louisiana laws on human trafficking
13	are properly implemented and provide training to law enforcement, the
14	judiciary, and service providers.
15	(8) Review the statutory response to human trafficking, analyze the
16	impact and effectiveness of strategies contained in Louisiana law, and make
17	recommendations on legislation to further anti-trafficking efforts.
18	(9) Develop mechanisms to promote public awareness of human
19	trafficking, including promotion of the national twenty-four-hour toll-free
20	hotline telephone service on human trafficking.
21	(10) Promote training courses and other educational materials for use by
22	persons required to undergo training on the handling of, and response
23	procedures for, suspected human trafficking activities.
24	(11) Develop a framework to collect and integrate data and measure
25	program outcomes.
26	(12) Receive reports and recommendations from the Human Trafficking
27	Prevention Commission Advisory Board.
28	(13) Do all other things reasonably necessary to accomplish the purposes
29	for which the commission is created.

1 C. In order to carry out its purposes and functions, the commission may 2 request data and assistance from state departments and agencies. When the 3 commission requests a state department or agency to provide needed data or assistance, the department or agency shall give priority to the request and shall 4 5 provide the data or assistance as requested. The commission shall maintain the confidentiality of any information or records provided to it by state 6 7 departments and agencies, as required by laws relative to such information and 8 records. 9 D. The commission shall annually issue a report of its findings and 10 recommendations to the governor, the speaker of the House of Representatives, 11 and the president of the Senate. The commission shall issue its initial report on 12 or before February 1, 2018, and shall issue annual reports no later than the first 13 day of February each year thereafter. The report may include any recommendations for legislation that the commission deems necessary and 14 15 appropriate. Legislation may be recommended by the commission only upon 16 approval by a two-thirds vote of the commission members present. 17 Comments - 2017 Part II of Chapter 28-B of Title 46 of the Revised Statutes is modeled on Senate 18 19 Concurrent Resolution No. 58 of the 2011 Regular Session and Senate Concurrent 20 Resolution No. 27 of the 2013 Regular Session. The commission shall be composed of the following members: 28 (1) The president of the Louisiana Senate or his designee. 29 (2) The speaker of the Louisiana House of Representatives or his

2	(3) The attorney general of the state of Louisiana or his designee.
3	(4) The secretary of the Louisiana Workforce Commission or his
4	designee.
5	(5) The state superintendent of education or his designee.
6	(6) The deputy secretary of the office of juvenile justice of the
7	Department of Public Safety and Corrections or his designee.
8	(7) The secretary of the Department of Children and Family Services or
9	his designee.
10	(8) The secretary of the Louisiana Department of Health or his designee.
11	(9) The secretary of the Department of Public Safety and Corrections or
12	his designee.
13	(10) The Superintendent of the Louisiana State Police or his designee.
14	(11) The President of the Louisiana Association of Chiefs of Police or his
15	designee.
16	(12) The Executive Director of the Louisiana Sheriffs' Association or his
17	designee.
18	(13) The chief justice of the Louisiana Supreme Court or his designee.
19	(14) A representative of the Human Trafficking Prevention Commission
20	Advisory Board selected by its members.
21	(15) The Executive Director of the Louisiana Commission on Law
22	Enforcement and Administration of Criminal Justice.
23	(16) The State Public Defender or his designee.
24	(17) The Executive Director of the Louisiana District Attorneys
25	Association or his designee.
26	B. Of the commission members provided in Subsection A of this Section,
27	one shall be appointed by the governor to serve as chairperson, and one shall be
28	appointed by the governor to serve as secretary.
29	C. Each member of the commission shall serve for a term concurrent

SB NO 42 1 with that of the governor. 2 D.(1) Each member shall be entitled to designate a single individual to serve as his proxy for the duration of the member's term on any occasion that 3 the member is unable to attend a meeting of the commission. The term of the 4 5 designated proxy shall be the same as that of the member. A member 6 appointing a designated proxy shall make his appointment known to the 7 chairperson and to the secretary of the commission. 8 (2) The proxy appointed by a member shall not be subject to the same 9 nominating and appointment procedures as is required for the member for 10 whom he is serving. 11 (3) An individual shall not serve as proxy pursuant to the provisions of 12 this Subsection for more than one member of the commission. 13 E. Legislative members of the commission shall receive the same per 14 diem and reimbursement of travel expenses as is provided for legislative 15 committees under the rules of the respective houses in which they serve. 16 Nonlegislative commission members shall serve without compensation or per 17 diem. **§2167.** Meetings 18 19 A. The commission shall hold public meetings quarterly except as 20 otherwise provided by vote of the commission or by order of the chairperson. 21 The governor shall call the first meeting by August 1, 2017. 22 B. A simple majority of the commission membership shall constitute a 23 quorum for the transaction of business. 24 C. The commission may establish subcommittees within the commission and appoint members to those subcommittees, including persons outside of the 25

2 §2168. Human Trafficking Prevention Commission Advisory Board A. The Human Trafficking Prevention Commission Advisory Board, 3 hereinafter referred to as the advisory board, is hereby created. The purpose 4 5 of the advisory board shall be to provide information and recommendations 6 from the perspective of advocacy groups, service providers, and victims. 7 Primary responsibilities of the Human Trafficking Prevention Commission 8 **Advisory Board are the following:** 9 (1) To ensure information sharing between governmental and 10 nongovernmental entities serving victims of human trafficking. 11 (2) To make recommendations to the Human Trafficking Prevention 12 Commission as requested by the commission. 13 (3) To make recommendations to the Human Trafficking Prevention 14 Commission as determined to be necessary by the advisory board. 15 (4) To make recommendations by August thirty-first of each year to the 16 **Human Trafficking Prevention Commission as to the budget priorities for the** 17 coming year. (5) To make recommendations by November thirtieth of each year to the 18 19 Human Trafficking Prevention Commission as to specific budget items to be 20 supported in the Children's Budget. 21 (6) To make an annual report by January thirty-first of each year to the 22 legislature, Senate Committee on Health and Welfare, the House Committee on Health and Welfare, Select Committee on Women and Children and any other 23 24 legislative committee requesting a copy of the annual report, which shall 25 summarize the well-being of Louisiana's children, the accomplishments of the past year, and specific goals and priorities for the next fiscal year. 26 27 B. The advisory board shall be composed of the following members 28 appointed by the governor: 29 (1) A public defender nominated by the Louisiana Public Defender

2	(2) A member nominated by the Louisiana District Attorneys
3	Association.
4	(3) A member nominated by the Louisiana Association of Juvenile and
5	Family Court Judges.
6	(4) A member nominated by the Louisiana Chapter, American College
7	of Emergency Physicians.
8	(5) A member nominated by the Louisiana Chapter, National Association
9	of Social Workers.
10	(6) An individual with expertise in advocacy for adult victims of human
11	trafficking.
12	(7) The executive director of a residential program for victims of human
13	trafficking.
14	(8) The executive director of a direct service program for victims of
15	human trafficking.
16	(9) An individual with expertise in advocacy for child victims of human
17	trafficking, nominated by the executive director of the Children's Cabinet or his
18	designee.
19	(10) At least two individuals who are adult survivors of human
20	trafficking, nominated by nonprofit organizations serving victims.
21	(11) A member nominated by Prevent Child Abuse Louisiana.
22	(12) A member nominated by the Juvenile Justice and Delinquency
23	Prevention Advisory Board.
24	(13) A member nominated by the Louisiana Families In Need Of Services
25	Association.
26	(14) A member nominated by the Louisiana Court-Appointed Special
27	Advocate Association.
28	(15) A member nominated by the Louisiana Association of Nonprofit
29	Organizations.

1	(16) A member with experience related to exploitation, nominated by the
2	Louisiana Council of Child and Adolescent Psychiatry or its designee.
3	(17) A member nominated by the Louisiana School Counselors
4	Association.
5	(18) A member nominated by the Louisiana Association of Childcare
6	Agencies.
7	(19) A member nominated by Louisiana Children's Advocacy Centers.
8	(20) A licensed psychologist with experience related to exploitation,
9	nominated by the Louisiana state board of examiners of psychologists.
10	(21) A member nominated by the Foundation Against Sexual Assault.
11	C. Each member shall serve for a term concurrent with that of the
12	governor. All members shall serve without compensation.
13	D. The advisory board shall be invited to all commission meetings and
14	may participate in its discussions but shall have no vote on any matter brought
15	before the commission.
16	E. The advisory board shall elect as officers a chairperson, vice
17	chairperson, and secretary from its membership and shall meet as needed. The
18	advisory board shall create its own bylaws. Unless the bylaws provide for a
19	greater quorum requirement, the presence in person or by proxy of one-third
20	of the members who have been appointed by the governor shall constitute a
21	quorum at the meetings of the advisory board.
22	F. The advisory board may appoint from time to time, to serve at its
23	pleasure, additional members to serve on matters about which such additional
24	members have expertise or experience. In the consideration of those matters for
25	which an additional member is appointed, he shall have the same powers and
26	duties during the period of his service as are enjoyed by the membership
27	provided by Subsection B of this Section.

<u>Proposed law</u> requires the commission to report annually to the governor and the legislature.

<u>Proposed law</u> provides that the commission is to be composed of the following members:

- (1) The president of the Senate or his designee.
- (2) The speaker of the House of Representatives or his designee.
- (3) The attorney general or his designee.
- (4) The secretary of the La. Workforce Commission or his designee.
- (5) The superintendent of education or his designee.
- (6) The deputy secretary of the office of juvenile justice of the Dept. of Public Safety and Corrections or his designee.
- (7) The secretary of the Dept. of Children and Family Services or his designee.
- (8) The secretary of the Dept. of Health or his designee.
- (9) The secretary of the Dept. of Public Safety and Corrections or his designee.
- (10) The superintendent of state police or his designee.
- (11) The president of the La. Association of Chiefs of Police or his designee.
- (12) The executive director of the La. Sheriffs' Association or his designee.
- (13) The chief justice of the supreme court or his designee.
- (14) A representative of the Human Trafficking Prevention Commission Advisory Board selected by its members.
- (15) The executive director of the La. Commission on Law Enforcement and Administration of Criminal Justice.
- (16) The State Public Defender or his designee.
- (17) The executive director of the La. District Attorneys Association or his designee.

<u>Proposed law</u> provides that one member of the commission is to be appointed by the governor to serve as chairperson, and one is to be appointed by the governor to serve as secretary.

Proposed law provides for the appointment of a proxy.

<u>Proposed law</u> provides that legislative members shall receive per diem and reimbursement for travel expenses and nonlegislative members shall serve without compensation.

<u>Proposed law</u> requires the commission to hold its first meeting by August 1, 2017 and provides that a simple majority constitutes a quorum.

<u>Proposed law</u> provides that the office of the governor shall provide clerical and technical support as needed.

Proposed law provides for the duties, membership, and appointment of the advisory board.

<u>Proposed law</u> provides that the board shall elect officers, adopt bylaws, and all members shall serve without compensation.

Effective August 1, 2017.
