Abstract: Modifies eligibility for the motion picture production tax credit and reduces the amount of the La. basic skills training tax credit.

<u>Present law</u> provides for an income tax credit for investments related to state-certified productions. The amount of the credit is determined by the amount of the investment.

<u>Proposed law</u> modifies eligibility for the tax credit by reducing the investment threshold amounts for the credit.

<u>Present law</u> provides for an income tax credit for corporations that pay for basic skills training for qualified employees. The amount of the credit is \$180 per trained employee, with a cap of \$21,600 in credits per taxpayer.

Proposed law reduces the amount of the credit from \$180 per trained employee to \$150.

Effective Jan. 1, 2018.
