3	(c) Submit a monthly report to the Joint Legislative Committee on the Budget
4	on all approved transfers approved in the prior month and all approved transfers for
5	the current fiscal year. The report shall include the transfers approved jointly with
6	the Joint Legislative Committee on the Budget and those that do not require approval
7	by the Joint Legislative Committee on the Budget. The commissioner of
8	administration shall also post the monthly report on the website maintained under
9	<u>R.S. 39:6(C).</u> "
