Provides relative to the crime of improper supervision of a minor with respect to off-road vehicles and golf carts

Proposed law amends and reenacts R.S. 14:92.2(B)(4) and enacts R.S. 14:92.2(A)(5) and (B)(5), relative to the crime of improper supervision of a minor by a parent or legal custodian. It also adds elements of the crime with respect to off-road vehicles, mini-trucks, utility terrain vehicles, or golf carts, provides for penalties and provides for related matters. Proposed law subjects any person who violates the provisions of proposed law to a fine of not more than \$100 and otherwise retains present law penalties.
