7	Section 1. R.S. 17:437.1(B) is hereby amended and reenacted and R.S.		
8	17:3996(B)(13) is hereby enacted to read as follows:		
9	§437.1. Suicide prevention; in-service training; materials and supplies; limitation		
10	on liability

12	B. The board shall adopt rules to require that all public and approved		
13	nonpublic school teachers, school counselors, and principals and, as determined by		
14	the board, other school administrators for whom such training is deemed beneficial		
15	participate annually in at least two hours of in-service training in suicide prevention		
16	and that such training begin not later than the 2008-2009 school year. Such rules		
17	shall include provisions permitting such training to be provided by self-review of		
18	suitable materials.

Abstract: Makes requirement for in-service training in suicide prevention applicable to nonpublic and charter school teachers, school counselors, principals, and other certain school administrators.

<u>Present law</u> requires the State Bd. of Elementary and Secondary Education (BESE) to develop and adopt rules to require all public school teachers, school counselors, principals, and as determined by the board, other school administrators to participate annually in at least two hours of in-service training in suicide prevention.

<u>Proposed law</u> retains <u>present law</u> and makes the requirement for in-service training in suicide prevention applicable to all charter and approved nonpublic school teachers, school counselors, principals, and as determined by the board, other school administrators.
