DISTRICTS/HOSPITAL SERVC Provides relative to the per diem paid to members of the board of commissioners of the Calcasieu Cameron Hospital Service District

Purpose of Bill: This measure allows the governing authorities of Calcasieu Parish and Cameron Parish to increase the per diem for members of the board of commissioners of Calcasieu Cameron Hospital Service District from \$100 to \$300 per meeting. The per diem is to be paid from funds of the hospital.

EXPENDITURE EXPLANATION

This bill may increase local fund expenditures by \$12,000 annually for Calcasieu Cameron Hospital Service District.

The proposed bill provides for an increase in per diem paid to each board member from \$100 to \$300 for each board meeting attended. This measure provides for a maximum of 12 meetings per year. Currently the district consists of 5 members who each receive \$100 for attending a maximum of 12 meetings.

If the board meets for the statutorily maximum allowable number of meetings, the current per diem would be \$6,000 annually (\$100 per diem x 12 meetings x 5 board members). If the board meets the maximum number of times with the increased per diem provided in this measure (\$300), expenditures would total \$18,000 annually (\$300 per diem x 12 meetings x 5 board members). Therefore the proposed legislation may increase local fund expenditures by \$12,000 annually (\$18,000 - \$6,000).

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
