

1 WHEREAS, in 2008, Mr. Willmott began his service as the state representative for
2 District 92 of the Louisiana House of Representatives, where he served on numerous
3 committees including the House Committee on Health and Welfare; the House Committee
4 on Municipal, Parochial and Cultural Affairs; the House Committee on Ways and Means;
5 the House Committee on Civil Law and Procedure; and the Joint Legislative Committee on
6 Capital Outlay; and

7 WHEREAS, during his time in the Louisiana House of Representatives,
8 Representative Willmott worked on and supported many important pieces of legislation,
9 including but not limited to at least eight laws and resolutions promoting the "Safe Haven
10 Law" and legislation creating the "Compassionate Burial Options Act" which provided
11 parents with the clear right to bury a miscarried child; and

12 WHEREAS, Mr. Willmott resigned from the House of Representatives on November
13 29, 2016, after running a very successful campaign for Kenner City Council where he won
14 the at-large seat he presently holds; and

15 WHEREAS, for his dedication to families and the protection of human life, Mr.
16 Willmott was honored with the 2017 Louisiana Right to Life Leadership for Life Award by
17 the Louisiana Right to Life Federation; and

18 WHEREAS, as Councilman Thomas P. Willmott embarks on the next exciting and
19 productive chapter of his life, he merits a sincere measure of commendation for his singular
20 contributions and the exemplary strides he has taken as an exceptional member of the
21 Louisiana House of Representatives and for his many professional and personal
22 accomplishments.

23 THEREFORE, BE IT RESOLVED that the House of Representatives of the
24 Legislature of Louisiana does hereby commend the Honorable Thomas P. Willmott; does
25 hereby extend honor and recognition to him for his outstanding accomplishments,
26 particularly during his tenure as a member of the Louisiana House of Representatives, which
27 has been marked by his uncompromising endeavor to improve the welfare of his constituents
28 in Jefferson Parish and the citizens of the state of Louisiana; and does hereby pay tribute to
29 the generous and effective way in which he has dedicated his intelligence and energy to the
30 service of his family, friends, community, and state.

2 of Louisiana hereby expresses enduring gratitude to the Honorable Thomas P. Willmott for
