8 On page 1, line 8, after "requirements;" delete the remainder of the line and on line 9 delete
9 "economically disadvantaged students;"

10 AMENDMENT NO. 4

11 On page 1, line 11, between "R.S." and "3991(B)(1)(a)(i)" change "17:3902(B)(5)," to
12 "17:3882(4) through (7), 3902(B)(5),"

13 AMENDMENT NO. 5

14 On page 1, line 12, between "R.S." and "hereby" change "17:3973(4) is" to "17:3882(8) and
15 3973(4) are"

16 AMENDMENT NO. 6

17 On page 1, between lines 12 and 13, insert the following:

18 "§3882. Definitions.

19 For the purposes of this Part, the following definitions shall apply:

20 * * *

21 (4) "Economic disadvantage" means any one of the following characteristics
22 of a student:

23 (a) Is eligible for Louisiana's food assistance program for low-income
24 families.

25 (b) Is eligible for Louisiana's disaster food assistance program.

26 (c) Is eligible for Louisiana's program for assistance to needy families with
27 children to assist parents in becoming self-sufficient.

28 (d) Is eligible for Louisiana's healthcare program for families and individuals
29 with limited financial resources.

30 (e) Is eligible for reduced price meals based on the latest available data.

31 (f) Is an English Language Learner.

32 (g) Is identified as homeless or migrant pursuant to the McKinney-Vento
33 Homeless Children and Youth Assistance Act and the Migrant Education Program
34 within the Elementary and Secondary Education Act.

35 (h) Is incarcerated with the office of juvenile justice or in an adult facility.

- 1 (i) Has been placed into the custody of the state.
- 2 ~~(4)~~ (5) "Evaluation" means the process by which a local board monitors the
- 3 continuing performance of its teachers and administrators.
- 4 ~~(5)~~ (6) "Local board" means a city, parish, or other local public school board.
- 5 ~~(6)~~ (7) "Performance expectations " means the elements of effective
- 6 leadership approved by the board that shall be included as evaluation criteria for all
- 7 building-level administrators.
- 8 ~~(7)~~ (8) "Teacher" or "Administrator" means any person whose employment
- 9 requires professional certification issued under the rules of the board.

16 "determined by the state board"
