2	To commend Louisiana's pregnancy resource centers, adoption agencies, social services,		
3	pro-life organizations, and pro-life citizens, and to recognize Thursday, May 11,		
4	2017, as Pro-Life Day at the state capitol.		
5	WHEREAS, all human life is a gift from our Creator and is sacred, unique, and		
6	worthy of protection, and each person, including every person waiting to be born, has a		
7	special place and purpose in this world; and		
8	WHEREAS, abortion unjustly takes the life of an innocent human baby and forever		
9	hurts the lives of women and men involved with abortion; and		
10	WHEREAS, many private citizens of Louisiana, acting out of love and compassion,		
11	have founded various agencies and centers dedicated to promoting a culture of life in our		
12	state; and		
13	WHEREAS, the more than forty pregnancy resource centers, adoption agencies, and		
14	maternity homes across Louisiana are working tirelessly to preserve this great gift of life by		
15	helping both unborn children and their mothers; and		
16	WHEREAS, for the past forty-four years, since the Supreme Court decided Roe v.		
17	Wade making abortion legal in Louisiana, these agencies have saved thousands and		
18	thousands of unborn children from abortion, and in recent years have helped reduce the		
19	annual number of abortions in Louisiana by nearly half; and		

1	WHEREAS, in addition to saving unborn lives, these agencies have empowered
2	mothers in difficult situations by providing the material and emotional support they need,
3	both before and after the birth of their child, to either parent or place their child for adoption;
4	and
5	WHEREAS, these agencies have consistently offered confidential counseling to
6	women and men who have experienced loss through abortion, miscarriage, and infertility;
7	and
8	WHEREAS, these life-affirming agencies out number abortion facilities in Louisiana
9	ten to one, showing through these agencies that Louisiana is a truly pro-life state; and
10	WHEREAS, the people of Louisiana support these agencies and their mission of
11	saving lives through volunteering, donations, prayer, and purchasing Choose Life license
12	plates, which funds grants for these agencies to continue their life-affirming work.
13	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
14	commend pregnancy resource centers, adoption agencies, social services, pro-life
15	organizations, and pro-life citizens and does hereby recognize Thursday, May 11, 2017, as
16	Louisiana Pro-Life Day at the state capitol.
17	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted

18 to the executive director of the Louisiana Right to Life Federation.
