BUDGETARY PROCEDURES

Requires the budgeted amount and authorized positions for the current year to be placed adjacent to the appropriation and authorized positions for the next year in the General Appropriation Bill and other appropriation bills

<u>Present law</u> requires that the General Appropriation Bill (GAB) and the bill appropriating funds for ancillary expenses contain a comparative statement of the number of authorized positions and the existing operating budget for the fiscal year and the appropriations for the ensuing fiscal year for each program, department and budget unit; requires that the GAB reflect the recommended expenditures by category for the ensuing fiscal year as contained in the Executive Budget supporting document; requires that the legislative and judicial appropriation bills include a comparative statement of the existing operating budget for the current fiscal year and the appropriations for the ensuing fiscal year.

<u>Proposed law</u> deletes the requirement for comparative statements for all three appropriation bills and instead requires the number of authorized positions and existing operating budget for the current fiscal year be placed adjacent to the number of authorized positions and the appropriations for the ensuing fiscal year; and requires that the GAB reflect recommended expenditures by category for the current fiscal year adjacent to recommendations for the ensuing one.
