AGRICULTURE: Urges and requests the Department of Agriculture and Forestry, in collaboration with the Louisiana State University Agricultural Center and Southern University Agricultural Research and Extension Center, to study the feasibility of promoting the growth, production, and use of organic produce in this state

A RESOLUTION

2	To urge and request the Department of Agriculture and Forestry, in collaboration with the
3	Louisiana State University Agricultural Center and Southern University Agricultural
4	Research and Extension Center, to study the feasibility of promoting the growth,
5	production, and use of organic produce in this state.
6	WHEREAS, Louisiana is losing revenue, taxes, jobs, and current and future
7	infrastructure because the state is not growing food for the local market; and
8	WHEREAS, Louisiana is also facing a public health crisis because of the foods
9	residents eat; and
10	WHEREAS, Louisiana is not regionally competitive in the local, school lunch,
11	organic, grass-fed cattle and dairy industry, or the small grains and brewers markets; instead,
12	Louisiana consumers, such as, bakers, butchers, brewers, markets, chefs, and schools,
13	purchase food that is grown outside of the state; and
14	WHEREAS, locally grown food, protected in a secure and direct market supply
15	chain, ensures our bio-security from certain threats like terrorism, war, and natural disasters;
16	and
17	WHEREAS, due to an immense generational shift in Louisiana, millennials are the
18	largest generation ever and they prefer locally grown food, which they are willing to pay a
19	premium for with their tremendous buying power; and

1 WHEREAS, Louisiana's agricultural community can choose to embrace or eschew 2 this local market, but many facets of our economy will suffer if Louisiana does not begin the 3 commitment to locally grown agricultural products; and 4 WHEREAS, a goal of this study is the establishment of a local and sustainable 5 agriculture department within the Louisiana State University Agricultural Center or the 6 Southern University Agricultural Research and Extension Center to study the seeds, markets, 7 cultures, consumers, and barriers to state markets, to research local preference programs, and 8 to research and expand the School Lunch Louisiana Program; and 9 WHEREAS, an additional goal of this study is the establishment of a Louisiana Food 10 Policy Council that will meet annually with the commissioner of the Department of 11 Agriculture and Forestry, the Louisiana State University Agricultural Center, the Southern 12 University Agricultural Research and Extension Center, and constituents such as chefs, 13 brewers, public health officials, doctors, millers, students, and other members of the general 14 public to: make policy recommendations for legislative sessions; establish an at-large 15 agricultural liaison between the division of administration, Louisiana State University, 16 Southern University, the Governor's office, and members of the general public; work with 17 appropriate legislative committees, including the House and Senate committees on 18 agriculture, forestry, aquaculture, and rural development, on legislation and policy 19 directives; and maintain the lawful, federal requirement that the Louisiana State University 20 Agricultural Center and the Southern University Agricultural Research and Extension Center 21 provide research and recommendations for all constituents in their districts. 22 THEREFORE, BE IT RESOLVED that the House of Representatives of the 23 Legislature of Louisiana does hereby urge and request the Department of Agriculture and 24 Forestry, in collaboration with the Louisiana State University Agricultural Center and the 25 Southern University Agricultural Research and Extension Center, to study the feasibility of 26 promoting the growth, production, and use of organic produce in this state, the establishment 27 of a local and sustainable agriculture department within the Louisiana State University 28 Agricultural Center or the Southern University Agricultural Research and Extension Center, 29 and the establishment of a Louisiana Food Policy Council.

BE IT FURTHER RESOLVED that the department shall submit a written report of

- 2 its findings and recommendations to the House and Senate committees on agriculture,
- 3 forestry, aquaculture, and rural development by February 1, 2018.
- 4 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 5 commissioner of the Department of Agriculture and Forestry, the dean of the Louisiana State
- 6 University Agricultural Center, and the chancellor-dean of the Southern University
- 7 Agricultural Research and Extension Center.
