5	housing entities that are subdivided into six regions across the state; and
6	WHEREAS, the Louisiana Housing Council (LHC) promotes and advances the
7	availability of affordable housing to approximately seventeen thousand low-income
8	residents, of which more than one-fourth are elderly and handicapped; and
9	WHEREAS, many of its member agencies provide a number of services related to
10	housing issues, which include job training, home ownership assistance, protective services,
11	child care, educational assistance, and youth services; and
12	WHEREAS, the Louisiana Housing Council strives to create stronger, more dynamic
13	communities and works together with other local agencies to enhance the quality of life for
14	citizens throughout the state; and
15	WHEREAS, the LHC awards scholarships to high school students based on academic
16	achievement, extracurricular activities, family need, and community involvement; and
17	WHEREAS, the organization honors the achievements of its outstanding members
18	who promote excellence in housing administration with exemplary leadership, high ethical

1	standards, and exceptional management skills with the presentation of the Philip W. Miller
2	Award; and
3	WHEREAS, the council constantly strives to provide decent, safe, and sanitary
4	housing and to reduce crime, poor health, and blighted property, thereby benefitting society

6	WHEREAS, the Louisiana Housing Council will hold its annual legislative
7	conference in Baton Rouge, Louisiana, May 16-19, 2017.
