MOTOR VEHICLES EG NO IMPACT See Note Provides relative to electronic verification of compulsory motor vehicle insurance

<u>Proposed law</u> requires law enforcement officers to use electronic means readily available to verify compulsory motor vehicle insurance at all traffic stops, including the names of the insured, the policy effective date, expiration date, a description of the vehicle(s) insured by the policy, and the current policy status. <u>Proposed law</u> requires motorists to provide evidence of compulsory motor vehicle insurance pursuant to <u>present law</u> if law enforcement officers are unable to verify insurance policies electronically. <u>Proposed law</u> requires the Dept. of Public Safety to promulgate rules as necessary to comply with proposed law.

EXPENDITURE EXPLANATION
