- "(2) The office of motor vehicles shall make the contract renewal package available on the its website. At least ninty days in advance of the expiration date of the contract the public license tag agent shall provide a complete application and any related documents required to renew the license to the office of motor vehicles, Incomplete or incorrect applications shall not be considered as a complete application. If the office of motor vehicles intends to renew its contract with a public license tag agent, the office of motor vehicles shall execute and return the new contract to the public license tag agent prior to the expiration of the contract.
- 15 "(3) If the office of motor vehicles does not intend to renew its contract with a public license tag agent, the office of motor vehicles shall send notice and cite the cause for failure 16 17 to renew, which shall be limited to the causes provided for in R.S. 47:532.2 (A) or 18 performance of the public licensed tag agent in fulfilling contract duties. The notice and 19 cause shall be sent to the public license tag agent within thirty days of receiving the 20 application from the public license tag agent. Unless the office of motor vehicles has issued 21 a cease and desist order to the public license tag agent pursuant to R.S. 47:532.3, or 22 suspended, revoked, cancelled or imposed other restrictions on the contract pursuant to R.S. 23 47:532.2, the office of motor vehicles shall allow the public license tag agent to operate until 24 the expiration of the contract. Any public license tag agent who receives a nonrenewal notice 25 may request an administrative hearing within five days of receiving the nonrenewal notice 26
- from the office of motor vehicles."

- 29 (5) Nothing in this Subsection shall prohibit the office of motor vehicles from 30 suspending, cancelling, or imposing other restrictions on a public license tag agent contract
- pursuant to R.S. 47:532.2, issuing a cease and desist order pursuant to R.S. 47:532.3, or 31
- 32 rescinding its offer to renew a contract prior to the expiration of the contract and instead
- 33 issuing a notice of nonrenewal.
