#### HOUSE BILL NO. 130

#### BY REPRESENTATIVE DEVILLIER AND SENATOR WALSWORTH

1	AN ACT
2	To amend and reenact R.S. 17:3882(4) through (7), 3902(B)(5), 3991(B)(1)(a)(i) and (b)(i),
3	and 3997(D)(2), to enact R.S. 17:3882(8) and 3973(4), and to repeal R.S. 17:3973(1),
4	relative to students; to provide that economically disadvantaged students shall be
5	included as a factor in determining teacher evaluations and requirements for
6	enrollment of at-risk students in certain charter schools; to remove references to
7	students eligible for free and reduced price meals as factors used in such teacher
8	evaluations and charter school enrollment requirements; and to provide for related
9	matters.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 17:3882(4) through (7), 3902(B)(5), 3991(B)(1)(a)(i) and (b)(i), and
12	3997(D)(2) are hereby amended and reenacted and R.S. 17:3882(8) and 3973(4) are hereby
13	enacted to read as follows:
14	§3882. Definitions.
15	For the purposes of this Part, the following definitions shall apply:
16	* * *
17	(4) "Economic disadvantage" means any one of the following characteristics
18	of a student:
19	(a) Is eligible for Louisiana's food assistance program for low-income
20	<u>families.</u>
21	(b) Is eligible for Louisiana's disaster food assistance program.

1	(c) Is eligible for Louisiana's program for assistance to needy families with
2	children to assist parents in becoming self-sufficient.
3	(d) Is eligible for Louisiana's healthcare program for families and individuals
4	with limited financial resources.
5	(e) Is eligible for reduced price meals based on the latest available data.
6	(f) Is an English Language Learner.
7	(g) Is identified as homeless or migrant pursuant to the McKinney-Vento
8	Homeless Children and Youth Assistance Act and the Migrant Education Program
9	within the Elementary and Secondary Education Act.
10	(h) Is incarcerated with the office of juvenile justice or in an adult facility.
11	(i) Has been placed into the custody of the state.
12	(4) (5) "Evaluation" means the process by which a local board monitors the
13	continuing performance of its teachers and administrators.
14	(5) (6) "Local board" means a city, parish, or other local public school board.
15	(6) $(7)$ "Performance expectations" means the elements of effective
16	leadership approved by the board that shall be included as evaluation criteria for all
17	building-level administrators.
18	(7) (8) "Teacher" or "Administrator" means any person whose employment
19	requires professional certification issued under the rules of the board.

21	§3902. Evaluation program; process
22	* * *
23	B. The elements of evaluation and standards for effectiveness shall be
24	defined by the board pursuant to rules and regulations promulgated for such purpose.
25	Such rules and regulations shall require that, at a minimum, local evaluation plans
26	contain the following elements:
27	* * *
28	(5) Measure of effectiveness. Fifty percent of such evaluations shall be
29	based on evidence of growth in student achievement as determined by the board.
30	Data derived from a value-added assessment model, as determined by the state

1	board, shall be a factor in determining evidence of student growth for grade levels
2	and subjects for which value-added data is available and shall comprise thirty-five
3	percent of the overall evaluation. For grade levels and subjects for which value-
4	added data is not available and for personnel for whom value-added data is not
5	available, the board shall establish measures of student growth. The model shall take
6	into account important student factors, including but not limited to special education,
7	eligibility for free or reduced price meals economic disadvantage, student
8	attendance, and student discipline. However, neither the value-added model nor the
9	measures of student growth for grade levels and subjects for which value-added data
10	are not available shall, in any given year, include a test score or data of a student who
11	has ten or more unexcused absences in any school semester in that year. The state
12	board shall develop and adopt a policy to invalidate such student growth data for any
13	teacher for any school year in which there is a natural disaster or any other
14	unexpected event that results in the temporary closure of the school.

16	§3973. Definitions
17	As used in this Chapter, the following words, terms, and phrases shall have
18	the meanings ascribed to them in this Section except when the context clearly
19	indicates a different meaning:

21	(4) "Economically disadvantaged" means any one of the following
22	characteristics of a student:
23	(a) Is eligible for Louisiana's food assistance program for low-income
24	families.
25	(b) Is eligible for Louisiana's disaster food assistance program.
26	(c) Is eligible for Louisiana's program for assistance to needy families with
27	children to assist parents in becoming self-sufficient.
28	(d) Is eligible for Louisiana's healthcare program for families and individuals
29	with limited financial resources.
30	(e) Is eligible for reduced price meals based on the latest available data.

1	(f) Is an English Language Learner.
2	(g) Is identified as homeless or migrant pursuant to the McKinney-Vento
3	Homeless Children and Youth Assistance Act and the Migrant Education Program
4	within the Elementary and Secondary Education Act.
5	(h) Is incarcerated with the office of juvenile justice or in an adult facility.
6	(i) Has been placed into the custody of the state.

8	§3991. Charter schools; requirements; limitations; renewal; amendment; revocation
9	* * *
10	B. Each proposed charter shall contain or make provision for the following:
11	(1)(a)(i) That for Type 1 and Type 2 charter schools created as new schools,
12	and charter schools created as a result of a conversion after the 2011-2012 school
13	year, the percentage of the total number of pupils students enrolled in the charter
14	school based on the October first pupil student membership who are at-risk, in the
15	manner provided in R.S. 17:3973(1)(a) and (e), economically disadvantaged and
16	students with exceptionalities as defined in R.S. 17:1942, not including gifted and
17	talented, shall be equal to not less than eighty-five percent of the average percentage
18	of pupils students enrolled in the local public school districts from which the charter
19	school enrolls its students who are eligible to participate in the federal free and
20	reduced lunch program economically disadvantaged, and shall be equal to not less
21	than eighty-five percent of the average percentage of pupils students enrolled in the
22	local public school districts from which the charter school enrolls its students who
23	have been identified as a student with an exceptionality as defined in R.S. 17:1942,
24	not including gifted and talented. The remaining number of pupils enrolled in the
25	charter school which would be required to have the same percentage of at-risk pupils
26	as the percentage of pupils in the district who are eligible to participate in the federal
27	free and reduced cost lunch program or who have been identified as a student with
28	an exceptionality as defined in R.S. 17:1942, not including gifted and talented, may
29	be comprised of pupils who are at-risk as is otherwise provided in R.S. 17:3973(1).
30	For the purposes of fulfilling the provisions of this Section, the at-risk economically

1	disadvantaged and students with exceptionalities percentage for the city or parish
2	school system local public school district shall remain fixed during the term of the
3	approved charter at the percentage which existed during the school year that the
4	charter proposal was approved, unless otherwise specified in the charter that the
5	charter school will reflect the current year's at-risk percentage. or renewed.

7	(b)(i) That for $\frac{1}{1}$ charter schools created as a result of a conversion,
8	Type 3 and Type 4 charter schools, during or prior to the 2011-2012 school year, the
9	percentage of the total number of pupils students enrolled in the charter school based
10	on the October first pupil student membership who are at-risk, in the manner
11	provided in R.S. 17:3973(1)(a) and (e), economically disadvantaged and students
12	with exceptionalities as defined in R.S. 17:1942, not including gifted and talented,
13	unless otherwise agreed to as part of the charter agreement, by the chartering
14	authority, shall be equal to not less than the percentage of the total of pupils students
15	enrolled in the school in the school year prior to the establishment of the charter
16	school that who were eligible to participate in the federal free and reduced cost lunch
17	program economically disadvantaged; and shall be equal to not less than the
18	percentage of the total of pupils students enrolled in the school in the school year
19	prior to the establishment of the charter school who were identified as a student with
20	an exceptionality as defined in R.S. 17:1942, not including gifted and talented.

26	(2) Fifty percent of each teacher and administrator evaluation conducted
27	pursuant to Paragraph (1) of this Subsection shall be based on evidence of growth in
28	student achievement as determined by the state board. Data derived from a value-
29	added assessment model, as determined by the state board, shall be a factor in
30	determining evidence of student growth for grade levels and subjects for which

1	value-added data is available and shall comprise thirty-five percent of the overall
2	evaluation. For grade levels and subjects for which value-added data is not
3	available, the state board shall establish measures of student growth. The model
4	shall take into account important student factors, including but not limited to special
5	education, eligibility for free or reduced price meals economic disadvantage, student
6	attendance, and student discipline. The state board shall develop and adopt a policy
7	to invalidate such student growth data for any teacher for any school year in which
