1 AN ACT 2 To amend and reenact R.S. 11:1821(B), (C), and (G), relative to the board of trustees of the 3 Municipal Employees' Retirement System of Louisiana; to provide for a trustee who 4 is a retired member; to provide for a term; to provide for elections; to provide for 5 implementation; and to provide for related matters. 6 Notice of intention to introduce this Act has been published 7 as provided by Article X, Section 29(C) of the Constitution 8 of Louisiana. 9 Be it enacted by the Legislature of Louisiana: 10 Section 1. R.S. 11:1821(B), (C), and (G) are hereby amended and reenacted to read 11 as follows: 12 §1821. Board of trustees; membership; term of office; oath of office; compensation; 13 voting power; vacancies 14 * B. The board shall be composed of eleven trustees as follows: 15 16 (1) Three active and contributing members of the system each of whom is 17 an elected official elected to office in accordance with the Louisiana Election Code 18 and has at least six years of creditable service. 19 (2) Three active and contributing <u>Two</u> members of the system who are not elected officials elected to office in accordance with the Louisiana Election Code, 20 21 each of whom has at least six years of creditable service. 22 (3) One retired member of the system.

1	(4) A vacancy on the board in a position held by an elected trustee shall be
2	filled for the unexpired term by election by the members of the system, as provided
3	in Paragraph (2) of this Subsection, except that if the unexpired term is less than two
4	years, the board may fill the vacancy by appointment; for the unexpired portion of
5	the term. If a trustee provided for in Paragraph (B)(1) or (2) of this Section retires,
6	he may continue to serve for the remainder of the term for which he was elected;
7	however, if he ceases to be a member, his term shall expire.

9	Section 2. Notwithstanding Section 2 of Act No. 225 of the 2014 Regular Session
10	of the Legislature, the board position provided for in R.S. 11:1821(B)(3) as amended by this
11	Act shall be filled in 2017 for an initial term of four years.
12	Section 3. This Act shall become effective upon signature by the governor or, if not
13	signed by the governor, upon expiration of the time for bills to become law without signature
14	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
15	vetoed by the governor and subsequently approved by the legislature, this Act shall become
16	effective on the day following such approval.
