8	WHEREAS, the Asian Chamber of Commerce of Louisiana, founded by business
9	owner, Tina Nguyen Owen, with the support and collaboration of cofounders, Mr. Quan
10	Huynh, Mr. Quang Nguyen, and Ms. Lucy Chun; and
11	WHEREAS, the Asian Chamber of Commerce of Louisiana strives to increase
12	business friendly legislation in all levels of government and assist its members to run their
13	business more effectively; and
14	WHEREAS, the Asian Chamber of Commerce of Louisiana recognizes that the
15	Asian-American population in Louisiana is 84,000 people and growing; and
16	WHEREAS, Tina Owen, its founder, recognizes the growing number of
17	Asian-owned businesses in Louisiana; and
18	WHEREAS, the number of Asian owned businesses is 11,000 and continually

2	WHEREAS, the Asian Chamber of Commerce of Louisiana's focus is connecting
3	business owners to share ideas and resources, resulting in numerous networking events
4	sponsored by the Asian Chamber of Commerce of Louisiana for its members and potential
5	members; and
6	WHEREAS, the Asian Chamber of Commerce of Louisiana facilitates economic ties
7	between Asian and non-Asian businesses while promoting its members' businesses to the
8	general public; and
9	WHEREAS, the Asian Chamber of Commerce of Louisiana's founding members
10	recognize that Asian buying power in Louisiana is \$3 billion and growing; and
11	WHEREAS, the Asian Chamber of Commerce of Louisiana established its First
12	Annual Gala in 2008 with the purpose of recognizing and honoring its business leaders with
13	awards in the following categories: Asian Business Excellence Award, Asian Business
14	Leader Award, and Emerging Asian Business of the Year Award; and
15	WHEREAS, the Asian Chamber of Commerce of Louisiana participated in numerous
16	networking events jointly with the Hispanic Chamber of Commerce and the New Orleans
17	Regional Black Chamber; and
18	WHEREAS, in celebration of its 10th anniversary, the Asian Chamber of Commerce
19	of Louisiana continues to expand its founders' vision of connecting and promoting Asian
20	owned businesses locally, statewide, and globally.
