12	Section 1. R.S. 47:4331(G), 6020(G), 6023(J), and 6037(J) are hereby enacted to

17	1950, comprised of R.S. 47:1121 through 1128, and Section 3 of Act No. 414 of the 2011
18	Regular Session of the Legislature as amended by Act No. 104 of the 2015 Regular Session
19	of the Legislature are hereby repealed.
20	Section 4. This Act shall become effective upon signature by the governor or, if not
21	signed by the governor, upon expiration of the time for bills to become law without signature
22	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
23	vetoed by the governor and subsequently approved by the legislature, this Act shall become
24	effective on the day following such approval.
