Abstract: Establishes an ad valorem tax exemption for property that is subject to a cooperative endeavor agreement that requires the property owner to make payments in lieu of ad valorem taxes.

<u>Present constitution</u> authorizes the imposition of ad valorem property taxes by local governments, school boards, and other special districts.

<u>Present constitution</u> authorizes a variety of exemptions from ad valorem tax.

<u>Proposed constitutional amendment</u> changes <u>present constitution</u> by establishing an exemption for property subject to a cooperative endeavor agreement that requires the property owner to make payments in lieu of the ad valorem taxes imposed by a taxing authority that is a party to the agreement. The exemption shall not exceed 10 years in duration. However, an exemption may exceed the 10 year limitation if recommended by the governor, and to the extent of the governor's recommendation.

<u>Proposed constitutional amendment</u> limits eligibility for the exemption to either a manufacturing establishment that qualifies for the industrial tax exemption, or a property subject to a cooperative endeavor agreement that has been approved by a legislative committee. <u>Proposed constitutional amendment</u> further prohibits eligibility for this exemption for a manufacturing establishment that has a contract for the industrial tax exemption, unless it is within the first two years of that contract.

<u>Proposed constitutional amendment</u> requires that exempt properties be listed on the assessment rolls and that information concerning those properties be submitted to the La. Tax Commission.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 6, 2018.
