LOCAL AGENCIES. Provides for an increase of commissioners to the Recreation and Park Commission for the parish of East Baton Rouge. (gov sig)

1	AN ACT
2	To amend and reenact R.S. 33:4570.1, relative to the Recreation and Park Commission for
3	the parish of East Baton Rouge; to provide for an increase on the board of
4	commissioners; and to provide for related matters.
5	Notice of intention to introduce this Act has been published.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 33:4570.1 is hereby amended to read as follows:
8	§4570.1. Board of commissioners; officers; quorum; employees
9	A. The commission shall be composed of three five ex officio members and
10	six appointed members for a total of nine eleven commissioners. The ex officio
11	members shall be the mayor-president, or an officer or employee of the city or parish
12	designated by the mayor-president from time to time; a member of the school board
13	of East Baton Rouge Parish, designated by the school board for a term coincident
14	with his term on the school board; and a member of the planning commission
15	designated by the planning commission for a term coincident with his term on the
16	planning commission; and the member of the Louisiana House of
17	Representatives or his designee, whose house district includes the Baton Rouge

1	Zoo; the member of the Louisiana Senate or his designee, whose senate district
2	includes the Baton Rouge Zoo; and the member of the Metro Council or his
3	designee, whose council district includes the Baton Rouge Zoo. At least one
4	member shall be chosen and appointed from a list of two names submitted by
5	the presidents of Louisiana State University and Agricultural and Mechanical
6	College and Southern University and Agricultural and Mechanical College and
7	have had the greater part of his experience as a licensed veterinarian. The six
8	appointed members shall be qualified voters of the parish appointed by the
9	metropolitan council for terms of three years. Vacancies shall be filled by the
10	designating or appointing body for the unexpired portion of the term. All
11	commission members shall serve without compensation.
12	B. The commission shall elect from the six appointed members a chairman,
13	a vice chairman, and a treasurer whose terms of office shall be one year. Four
14	members shall constitute a quorum of the commission for all purposes. The

commission shall have the power and authority to name and employ a person who
shall be designated as superintendent of the commission, who shall not be a member
of the commission, and who shall be ex officio secretary of the commission, and to

18 prescribe and pay an annual salary to the superintendent.

Section 2. This Act shall become effective upon signature by the governor or, if not
signed by the governor, upon expiration of the time for bills to become law without signature
by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
vetoed by the governor and subsequently approved by the legislature, this Act shall become
effective on the day following such approval.

<u>Present law</u> provides for the board of commissioners of the East Baton Rouge Parish Recreation and Park Commission to be composed of nine commissioners: three ex officio members and six appointed members.

Present law provides that the ex officio members are to be the mayor-president, or an officer

<u>Present law</u> requires four members of the commission to constitute a quorum for all purposes.

<u>Proposed law</u> provides for an increase in the number of commissioners <u>from 9 to 11</u> for the Recreation and Park Commission for the parish of East Baton Rouge.

<u>Proposed law</u> provides for the removal of a member of the school board of East Baton Rouge Parish as an ex officio member and replaces him with the member of the Louisiana House of Representatives, the member of the Louisiana Senate, and the member of the Metro Council or their designees, whose districts include the Baton Rouge Zoo. <u>Proposed law</u> also provides that at least one member shall be chosen and appointed from a list of two names submitted by the presidents of Louisiana State University and Agricultural and Mechanical College and Southern University and Agricultural and Mechanical College and have had the greater part of his experience as a licensed veterinarian.

Effective upon signature of the governor or lapse of time for gubernatorial action.
