15	(2) The legislature further finds that the purpose of this Part is to allow		
16	owners of property classified as forest land or bona fide timberland, as defined in		
17	<u>R.S. 47:2302(D)</u> , to conduct activities relating to forest production <u>or harvesting</u> or		
18	if a governmental entity prohibits or severely limits such activities, to compensate		
19	the owners for their losses at fair market value.

(3) No liability bond or certificate of insurance shall be required on any road by any entity for transporting harvested timber from a forest or log storage site to a primary processing facility.

Abstract: Requires governmental entities to compensate property owners at fair market value for restricting certain forest activities. Prohibits the use of liability bonds and certificates of insurance by any entity for the transportation of harvested timber.

Present law authorizes owners of forest land to conduct forest production activities.

Proposed law expands present law to include bona fide timberland and forest harvesting.

<u>Present law</u> requires governmental entities to compensate property owners for their losses when the entity prohibits or severely limits forest production.

<u>Proposed law</u> requires the compensation to be at fair market value.

<u>Proposed law</u> prohibits governmental entities from requiring liability bonds or certificates of insurance for the transportation of harvested timber.
