D.(1) No defendant shall be admitted to the pilot program prior to court approval of the defendant's participation in the pilot program.  (2) Notwithstanding any other provision of law to the contrary, the court, at any time on its own motion, may prohibit or terminate a defendant's initial or continued participation in the pilot program."
