R.S. 32:663(B) is hereby amended and reenacted to read as follows: 8 §663. Approval of testing methods by Department of Public Safety and Corrections 9 10 B. The Department of Public Safety and Corrections may use an individual's 11 current certification to a nationally or internationally recognized certification body 12 or a laboratory's certification by one or more of the following professional 13 organizations current accreditation to an accreditation program based on the 14 international standard, ISO/IEC 17025, with an accreditation scope that includes 15 toxicology or blood alcohol, in its determination of the qualifications and 16 competence of individuals or laboratories as required by Subsection A of this Section 17 prior to the issuance of a permit. The certification by the following professional 18 organizations may be considered in issuing such permits:

**Abstract:** Changes the requirements for the Dept. of Public Safety to use in its determination of the qualifications and competence of individuals and laboratories who perform chemical analysis for the department.

<u>Present law</u> provides a list of accreditation bodies which the Dept. of Public Safety and Corrections (department) may use to issue permits for the purposes of chemical analysis testing.

<u>Proposed law</u> modifies <u>present law</u> by removing the list of accreditation bodies and instead allows the department to use an individual or laboratory with an accreditation based upon the international standard, ISO/IEC 17025, for the purposes of chemical analysis testing.
