Abstract: Specifies that during each day of early voting and on election day voting machines shall be in full view of the public from the time the polling place is opened until the last elector has voted.

<u>Present law</u> (R.S. 18:1374) provides that to the extent possible, the authority charged with the selection of polling places shall designate polling places which are equipped with proper electric current, fixtures, and outlets necessary to properly operate the voting machines and otherwise conduct the election. Provides that each voting machine shall be placed inside the polling place and be in full view of the public. Provides that the commissioners and watchers shall be stationed near the voting machines, that the commissioners shall regulate the admission of the voters thereto, and that each shall always be in full view of the other election commissioners and watchers and, as far as possible, of the public.

<u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> provides that the voting machines must be in full view of the public from the time the election begins until the last elector has voted.

<u>Proposed law</u> provides that the voting machines shall be in full view of the public beginning when the polling place is opened, instead of when the election begins. Specifies that the requirement applies during each day of early voting to voting machines used during early voting and on election day to machines used on election day.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on House and Governmental Affairs</u> to the <u>original</u> bill:

1. Clarify that the requirement to keep voting machines in full view of the public applies during each day of early voting to voting machines used during early voting and on election day to machines used on election day.
