7	Pierre and is from Ama, Louisiana, a small town on the west bank of St. Charles Parish; and
8	WHEREAS, she studies mass communication with a concentration in public relations
9	and minors in business administration and African and African American studies at
10	Louisiana State University (LSU) in Baton Rouge, Louisiana; and
11	WHEREAS, Tayler's passion for education, faith, and service are the impetus for her
12	collegiate studies and involvement in extracurricular activities; and
13	WHEREAS, she has maintained a 4.1 grade point average and has been on the
14	President's Honor Roll; and
15	WHEREAS, Tayler is an LSU Summer Scholar and President's Millennial Scholar
16	and also serves as a resident assistant in Miller Hall and a student worker for the LSU Sports
17	Information Department; and
18	WHEREAS, she serves as the music chair for the Student Activities Board, public

1	relations officer for The Impact Movement, diversity ambassador for the Office of Diversity,
2	a team leader for Springfest, and a peer mentor and assistant for the Summer Scholars
3	Program; and
4	WHEREAS, in addition to being involved in the LSU community, Tayler serves the
5	surrounding community of Baton Rouge through volunteer work at the Carver Branch of the
6	East Baton Rouge Libraries and participation in the Geaux Big Baton Rouge day of service;

8	WHEREAS, she traveled to Detroit, Michigan, last spring on an inner-city mission
9	trip and most recently became involved with Connections For Life (CFL), a transitioning
10	program for previously incarcerated women, and during the summer of 2018, Tayler will be
11	traveling to South Africa on a mission trip; and
12	WHEREAS, Tayler is a TOPS Scholar, the recipient of the A.P. Tureaud Sr. Black
13	Alumni Chapter Scholarship, the Dr. Gerald and Gayle Foret University College Award, and
14	the Black Faculty and Staff Caucus Award; and
15	WHEREAS, the Louisiana Legislative Women's Caucus Foundation created the
16	Women of Excellence Awards to recognize and honor extraordinary women of excellence
17	across the state for their outstanding achievements and contributions; and
18	WHEREAS, recipients of the Women of Excellence Awards exhibit characteristics
19	of integrity and professionalism, personify excellence in their area of specialty, and are
20	committed to community service to better society as a whole; and
21	WHEREAS, for 2018, there are two categories for the Women of Excellence
22	Awards: College Women of Excellence and High School Women of Excellence; and
23	WHEREAS, the recipients of the 2018 Women of Excellence Awards are being
24	recognized at the Louisiana Legislative Women's Caucus Foundation's Women of
25	Excellence Awards & Scholarships Ceremony and Reception on Tuesday, April 24, 2018;

27	WHEREAS, Tayler has been named a recipient of a 2018 Women of Excellence
28	Award in the category of College Women of Excellence and is also a recipient of a
29	Louisiana Legislative Women's Caucus Foundation Scholarship for her accomplishments
