26 sheriff, deputy sheriff, marshal, deputy marshal, correctional officer,
27 constable, wildlife enforcement agent, and probation and parole officer.
28 "Police officer" shall also include any licensed emergency medical services
29 practitioner as defined by R.S. 40:1131 and any firefighter regularly
30 employed by a fire department of any municipality, parish, or fire protection
31 district of the state or any volunteer firefighter of the state."
