6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 3:2363.1 is hereby enacted to read as follows:
8	§2363.1. Raffle of animals as novelties or prizes prohibited; exemptions;
9	<u>penalty</u>
10	A. No person, firm, or corporation shall raffle or give away any animal
11	as a novelty or prize at a carnival or fair.
12	B. For purposes of this Section, the term "animal" means an iguana, a
13	pot-bellied pig, or a reptile.
14	C. Nothing in this Section shall prohibit a humane society, animal
15	shelter, or a pet shop from caring for, adopting, or selling animals as pets.
16	D. Nothing in this Section shall prohibit a hunting club from raffling
17	hunting dogs.

E. A local governing authority may establish a fine of not more than one

hundred dollars per violation. Each day on which a violation occurs shall

constitute a separate offense.

<u>Proposed law</u> prohibits raffling or giving away any animal as a novelty or prize at a carnival or fair.

Proposed law defines the term "animal" as an iguana, a pot-bellied pig, or a reptile.

<u>Proposed law</u> exempts a humane society, animal shelter, or a pet shop from caring for, adopting, or selling animals as pets from the provisions of <u>proposed law</u>.

<u>Proposed law</u> exempts hunting clubs that raffle hunting dogs from the provisions of proposed law.

<u>Proposed law</u> authorizes a local governing authority to establish a fine of not more than \$100 per violation. Each day on which a violation occurs constitutes a separate offense.

Effective August 1, 2018.

Summary of Amendments Adopted by Senate

Committee Amendments Proposed by Senate Committee on Agriculture, Forestry, Aquaculture, and Rural Development to the original bill

- 1. Removes chickens, ducks, rabbits, fish, birds and turtles from the definition of "animal".
- 2. Authorizes a local governing authority to establish a fine of not more than \$100 per violation and makes penalty provisions permissive rather than mandatory.

Senate Floor Amendments to engrossed bill

1. Makes Legislative Bureau technical changes.
