## **EXPENDITURE EXPLANATION**

<u>Proposed law</u> may impact SGF expenditures for the Department of Public Safety and Corrections - Correction Services if a person is convicted of criminal abortion, first degree feticide, second degree feticide, third degree feticide and abortion as a crime of violence. By adding the aforementioned crimes to the list of crimes of violence, certain eligibility opportunities may be prohibited under specific parts of the law with respect to certain considerations such as, but not limited to: *diminution and commutation of sentence for good behavior, suspended sentences and probation, and parole eligibility*. To the extent designation of these crimes as crimes of violence may lengthen incarceration for certain convictions, DPSC may realize increased expenditures.

Corrections services realizes SGF expenditures of \$54.21 per offender per day if an offender is housed in a state facility or \$24.39 for a state offender housed in a local facility. An offender sentenced to the custody of the Department of Public Safety and Corrections - Correction Services for one year creates SGF expenditures of \$19,786.65 (\$54.21 per day x 365 days) if housed in a state facility and \$8,902.35 (\$24.39 per day x 365 days) if housed in a local facility. Approximately 50% of state offenders are housed in state facilities and approximately 50% of state offenders are housed in local facilities.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
