15 SUBPART L. PAYMENT OF JUDGEMENTS FUND

16 §100.36. Payment of Judgements Fund; order of payment of judgments

A. The "Payment of Judgments Fund", hereinafter referred to as the 17 fund, is hereby created in the state treasury. Interest earned on the investment 18 19 of monies in the fund shall be deposited in and credited in the fund. 20 Unexpended and unencumbered monies in the fund at the close of each fiscal year shall remain in the fund. Monies in the fund shall be appropriated, 21 22 administered, and used solely and exclusively for the purpose of satisfying final 23 nonappealable judgments and compromises against the state as further 24 provided in this Section.

25B. The fund shall be comprised of all monies appropriated, donated, or26otherwise made available to provide funding to satisfy and pay judgments27against the state. All of such monies required to be deposited in the state28treasury in accordance with Article VII, Section 9(A) of the Constitution of29Louisiana shall be deposited in the fund after first meeting the requirements of30Article VII, Section 9(B) of the Constitution of Louisiana relative to the Bond31Security and Redemption Fund.

32C. Annually, the Office of Risk Management shall notify the33commissioner of administration of all final nonappealable judgments and34compromises which cannot be paid from the Self-Insurance Fund as of35December thirty-first. The governor may then include in the executive budget36an amount sufficient to pay such judgments or compromises, including judicial37interest and costs. The legislature may appropriate into the fund such monies38as it deems necessary and appropriate to pay such judgments."
