BOARDS/COMMISSIONS: Creates the Slavery Ancestral Burial Grounds Preservation Commission

A CONCURRENT RESOLUTION

2	To create and establish the Slavery Ancestral Burial Grounds Preservation Commission to
3	study and develop measures to preserve and protect unmarked and historic burial
4	grounds, graves, and cemeteries of the formerly enslaved in Louisiana.
5	WHEREAS, preservation of the burial grounds and cemeteries of slaves is significant
6	because they represent not only an important part of the cultural heritage of Louisiana, but
7	America; and
8	WHEREAS, although most burial grounds and cemeteries of the formerly enslaved
9	contain unmarked graves, the research uncovered from these burial places reveals
10	information about how the people lived, their connections to each other and the surrounding
11	community of plantations, and most of all, their connections to the descendants living now;
12	and
13	WHEREAS, most records regarding burial grounds and cemeteries of the formerly
14	enslaved are limited to plantation inventories and incomplete census records; nevertheless,
15	these are sacred grounds that should be regarded as such; and
16	WHEREAS, the discovery of these grounds and cemeteries is instrumental in helping
17	families trace their family roots; moreover, it is important that these sacred spaces are
18	preserved and protected to ensure that the knowledge about the legacy of the enslaved and
19	free people who worked on the plantations is preserved for future generations; and

1	WHE	REAS, the state of Louisiana acknowledges the humanity of all the people	
2	buried in long-lost graves along the Mississippi River; and		
3	WHE	REAS, the state of Louisiana also acknowledges their contributions to the	
4	economy and	culture of this great state and this nation; and	
5	WHE	REAS, by acknowledging and protecting these sites, we are presenting a	
6	meaningful w	ay to better understand the reality of slavery, which will hopefully give us a	
7	better underst	anding of the heritage and history of our friends, colleagues, and neighbors.	
8	THER	EFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby	
9	create the Slav	very Ancestral Burial Grounds Preservation Commission to study and develop	
10	measures to	preserve and protect unmarked and historic burial grounds, graves, and	
11	cemeteries of	the formerly enslaved in Louisiana.	
12	BE I	Γ FURTHER RESOLVED that the commission shall be comprised of	
13	representative	es assigned from relevant and interested state agencies and other relevant and	
14	interested par	ties, including but not limited to all of the following:	
15	(1)	Two members from the office of cultural development within the Department	
16		of Culture, Recreation and Tourism, in the office of the lieutenant governor:	
17		the state archaeologist and the director of the division of historic	
18		preservation.	
19	(2)	One member of the Louisiana House of Representatives appointed by the	
20		speaker of the House of Representatives.	
21	(3)	One member of the Louisiana Senate appointed by the president of the	
22		Senate.	
23	(4)	The chair of the Louisiana Legislative Black Caucus or his designee.	
24	(5)	The executive director of the Louisiana Sheriff's Association or his designee.	
25	(6)	The chair of the Louisiana Cemetery Board or his designee.	
26	(7)	The executive director of Save Our Cemeteries or his designee.	
27	(8)	The president of the Le Comité des Archives de la Louisiane, Inc. or his	
28		designee.	
29	(9)	The president of the National Association for the Advancement of Colored	
30		People (NAACP) or his designee.	

1	(10)	The chair of the Baton Rouge Metropolitan Black Chamber of Commerce of
2		his designee.
3	(11)	One representative of the office of research and strategic initiatives of the
4		Southern University and Agricultural and Mechanical College.
5	(12)	The attorney general or his designee who is an attorney.

22	BE IT	FURTHER RESOLVED that the commission is assigned to the office of the
23	lieutenant gov	vernor with staff support to be provided from existing personnel within the
24	office.	
25	BE IT	FURTHER RESOLVED that, at the first meeting of the commission, the
26	members may	y elect a chairman, vice chairman, and other officers as they may deem
27	appropriate.	
28	BE IT	FURTHER RESOLVED that the commission shall be domiciled in Baton
29	Rouge but ma	y hold public meetings elsewhere in the state.
30	BE IT	FURTHER RESOLVED that the commission shall meet as necessary and

shall serve without compensation and at no expense to the state.

1	BE IT FURTHER RESOLVED that member vacancies shall be filled in the same		
2	manner as the original appointments.		
3	BE IT FURTHER RESOLVED that the purpose of the commission shall be to create		
4	a written report of existing local, state, and federal cemetery protection laws to determine		
5	rules and regulations for the identification, protection, and preservation of such grounds and		
6	cemeteries and to make suggestions for additional laws to protect these sacred sites to the		
7	House Committee on Commerce and the Senate Committee on Commerce, Consumer		
8	Protection, and International Affairs on or before the end of the sixth month following the		
9	commission's first meeting.		
10	BE IT FURTHER RESOLVED that the commission shall submit a second written		
11	report to the House Committee on Commerce and the Senate Committee on Commerce,		
12	Consumer Protection, and International Affairs on or before the end of one year following		
13	the release of the first report. This second report shall consist of the commission's findings		
14	and recommendations, including proposed legislation if necessary and reasons therefore, on		
15	each of the following:		
16	(1) A cost-effective mechanism for cataloging unmarked and historic burial		
17	grounds, graves, and cemeteries of slaves in Louisiana.		
18	(2) Measures designed to protect the location of these sites from desecration.		
19	BE IT FURTHER RESOLVED that the commission shall submit a third written		
20	report to the House Committee on Commerce and the Senate Committee on Commerce,		
21	Consumer Protection, and International Affairs on or before the end of one year following		
22	the release of the second report. This third report shall consist of the commission's findings		
23	and recommendations, including proposed legislation if necessary and reasons therefore, on		
24	each of the following:		
25	(1) Funding sources for the preservation and protection of these sites in		
26	conjunction with the River Road African American Museum.		
27	(2) Methods for incorporating findings into educational history for students in		
28	kindergarten through twelfth grade.		
29	(3) Strategies for incorporating historical sites as tourist attractions in this state.		
30	BE IT FURTHER RESOLVED that the commission may form any number and		
31	configuration of committees to accomplish the goals set forth herein.		

BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted

2 to the appointing entities named in this Resolution.

Creates the Slavery Ancestral Burial Grounds Preservation Commission to study and develop measures to preserve and protect unmarked and historic burial grounds, graves, and cemeteries of the formerly enslaved in the state of La.

Requires the commission to submit three reports of its findings to the House Committee on Commerce and the Senate Committee on Commerce, Consumer Protection, and International Affairs, the first on or before the end of the sixth month following the commission's first meeting, the second on or before the end of one year following the release of the first report, and the third on or before the end of one year following the release of the second report, respectively.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Municipal, Parochial</u> and <u>Cultural Affairs</u> to the <u>original resolution</u>:

- 1. Replace the director of the office of cultural development with the director of the division of historic preservation as a member of the commission.
- 2. Replace the president of the National Assoc. for the Advancement of Colored People (NAACP) Baton Rouge branch with the president of the NAACP as a member of the commission.
- 3. Add the president of the National Urban League or his designee to the commission.
- 4. Delete provision designating the state archaeologist and director of the office of cultural development as chair of the commission and provide for election of a chairman.
- 5. Change deadline for the submission of a report to the House Committee on Commerce and the Senate Committee on Commerce, Consumer Protection, and International Affairs <u>from</u> Feb. 1, 2019, <u>to</u> within sixth months of the commission's first meeting.
- 6. Add requirements that commission present two additional reports to the House Committee on Commerce and the Senate Committee on Commerce, Consumer Protection, and International Affairs.
- 7. Add provision authorizing commission to form any number and configuration of committees.
