Holders of a Class A-Transporter permit shall be authorized to deliver alcoholic beverages intended for personal consumption and in manufacturer 20 21 sealed containers on behalf of a person or entity that is the holder of any valid retail 22 dealer licensed in accordance with this Title. A holder of a Class A-Transporter permit 23 shall not be authorized to deliver alcoholic beverages to any manufacturer, wholesaler, 24 or retail dealer licensed in accordance with this Title. The fee for a Class A-
- 25 Transporter permit shall not exceed the fees for a Class A-General permit set forth in
- 26 **R.S. 26:71(A).**
