COMMENDATIONS: Commends posthumously former state representative Ernest Nathan "Dutch" Morial

A RESOLUTION

2	To commend posthumously the former and late Louisiana legislator and mayor of New
3	Orleans, the Honorable Ernest Nathan "Dutch" Morial, for his purpose-filled life of
4	public service and dismantling racial barriers.
5	WHEREAS, affectionately known as "Dutch", Ernest Nathan Morial, the youngest
6	of six children was born on October 9, 1929, in New Orleans, Louisiana, to Leonie V. and
7	Walter Etienne Morial; Ernest Morial made his transition on December 24, 1989, at the age
8	of sixty; and
9	WHEREAS, Ernest "Dutch" Morial was a skillful attorney, political icon, and civil
10	rights activist known for achieving many firsts throughout his life; Mr. Morial was known
11	for being a person of resourcefulness, an advocate, and a trailblazer; and
12	WHEREAS, Mr. Morial was an accomplished politician who had a genuine heart and
13	concern for people and his community; his commitment to being a servant and leader and
14	his dedication to equality and social justice were hallmarks of his character; and
15	WHEREAS, Ernest Nathan "Dutch" Morial earned a bachelor of science in business
16	administration from Xavier University in 1951; he later went on to become the first African
17	American to receive a law degree from Louisiana State University Law School (now known
18	as the Paul M. Hebert Law Center) in 1954; and

1	WHEREAS, Mr. Morial served in the U.S. Army Intelligence Corps during the
2	Korean conflict from 1954 to 1956; and
3	WHEREAS, he married Sybil G. Hayden in 1955, and to this union, five children
4	were born: Julie, Marc, Jacques, Cheri, and Monique; and
5	WHEREAS, after serving in the military, Mr. Morial returned to his law practice in
6	New Orleans in 1956 to serve as general counsel to the Standard Life Insurance Company
7	until 1967; Mr. Morial served as assistant U.S. attorney for New Orleans from 1965 to 1967;
8	and
9	WHEREAS, as president of the New Orleans Chapter of the National Association
10	for the Advancement of Colored People (NAACP) from 1962 to 1965, Mr. Morial was at
11	the forefront of black protests and the dismantling of Jim Crow laws; he became an attorney
12	with the NAACP Legal Defense and Educational Fund, serving on the national level; and
13	WHEREAS, Mr. Morial participated in the 1960 Dryades Street boycott and fought
14	for the desegregation of buses and streetcars and the integration of Louisiana State
15	University of New Orleans; he also broke many barriers for other African Americans by
16	filing successful suits to end desegregation practices in New Orleans and Louisiana
17	including in the city's public schools, recreation department, taxicabs, airport, and municipal
18	auditorium; and
19	WHEREAS, in 1967, Mr. Morial was elected to the Louisiana state legislature,
20	becoming the first African American elected since Reconstruction; he was also the first
21	African American assistant U.S. attorney in New Orleans, the first African American to
22	serve as juvenile court judge, and the first African American on the Fourth Circuit Court of
23	Appeals; and
24	WHEREAS, in 1977, Mr. Morial announced his candidacy for mayor of New
25	Orleans and sued the State Judicial Commission for the right to campaign while remaining
26	a judge; Mr. Morial won the general election by six thousand votes, becoming the first
27	African American mayor of New Orleans; and
28	WHEREAS, Mr. Morial gained national attention in his first term as mayor by
29	standing up to police and sanitation workers, which in turn led to a city-wide strike resulting
30	in the cancellation of the celebration of Mardi Gras in 1979; and

1 WHEREAS, in 1982, Mr. Morial was re-elected as mayor of New Orleans; two years 2 later, he was elected president of the United States Conference of Mayors; and 3 WHEREAS, the citizens of the city of New Orleans and the state of Louisiana will 4 always be indebted to Mr. Morial's commitment to making a difference in the lives of others; 5 Mr. Morial has inspired many through his selfless efforts; he serves as an example of what 6 one can do by committing one's life to Christ, family, and friends and working hard to 7 accomplish goals that are within God's will for this life. 8 THEREFORE, BE IT RESOLVED that the House of Representatives of the 9 Legislature of Louisiana does hereby commend posthumously former state representative 10 and mayor of New Orleans, Ernest Nathan "Dutch" Morial; does hereby celebrate his legacy 11 and salute his purpose-filled life of dismantling racial barriers, building alliances, and 12 improving the quality of life for the people of the city of New Orleans and the state of 13 Louisiana. 14 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 15 to the family of Ernest Nathan "Dutch" Morial.
