<u>Present law</u> establishes the LA Life and Health Insurance Guaranty Association. <u>Present law</u> provides that the association is not considered a state subdivision. <u>Proposed law</u> adds health maintenance organizations as members of the association. <u>Proposed law</u> adds association assessments for long-term policies and contracts. <u>Proposed law</u> adds an authorization for the reissuance of policies or contracts by the association. <u>Proposed law</u> retains present law regarding the powers of the Commissioner of Insurance. <u>Proposed law</u> repeals present law authorizing the board of directors to request the commissioner order an examination of any member insurer which the board believes may be insolvent. <u>Proposed law</u> repeals <u>present law</u> requiring the board of directors to prepare a report for the commissioner containing information regarding information relative to the history and causes of any insurer insolvency. <u>Proposed law</u> provides which sections of <u>present law</u> govern the liquidation or windup of a health maintenance organization.
